

A total of 107 companies were formed in Calne in 2011. This total is 42.7% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Calne when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Calne when compared to any half year in history.

Q4 2011 saw a new record in company registrations in Calne when compared to any previous Q4.


Q4 2011 was a record quarter for company registrations in Calne when compared to any quarter in history.








A total of 16 companies were dissolved in Calne during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 40 companies were added to the company register for Calne in 2011. This number represents growth of 53.3% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Calne during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 16 companies.

net growth by quarter






company share by year







director age by year




director age by half year

director gender by year




Half Year Data (Jul-Dec 2011)
