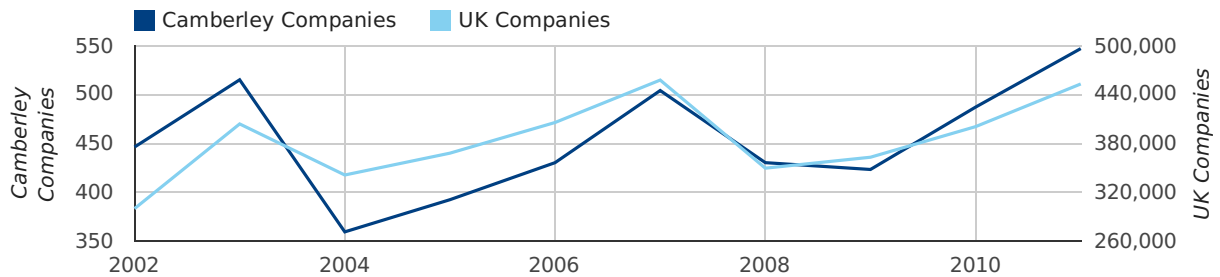
Annual Data (2011)

2011 was a record year for company registrations in Camberley when compared to any year in history.

A total of 547 companies were formed in Camberley in 2011. This total is 12.3% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Camberley when compared to any previous second half year.

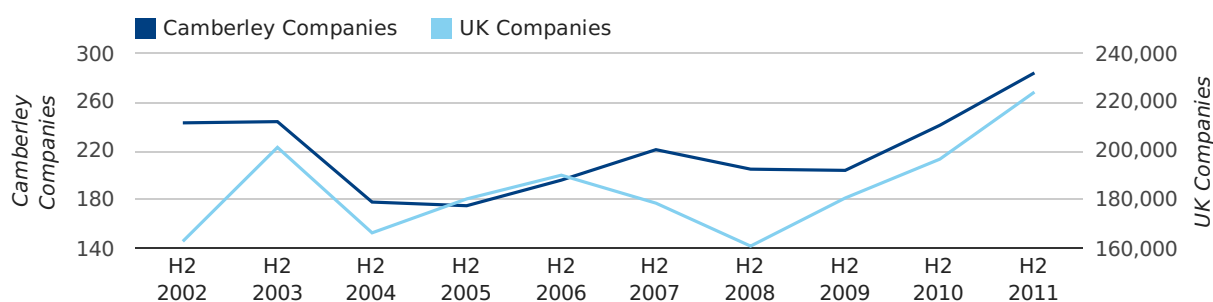
The second half of 2011 was a record second half year for company registrations in Camberley when compared to any half year in history.

new companies by half year



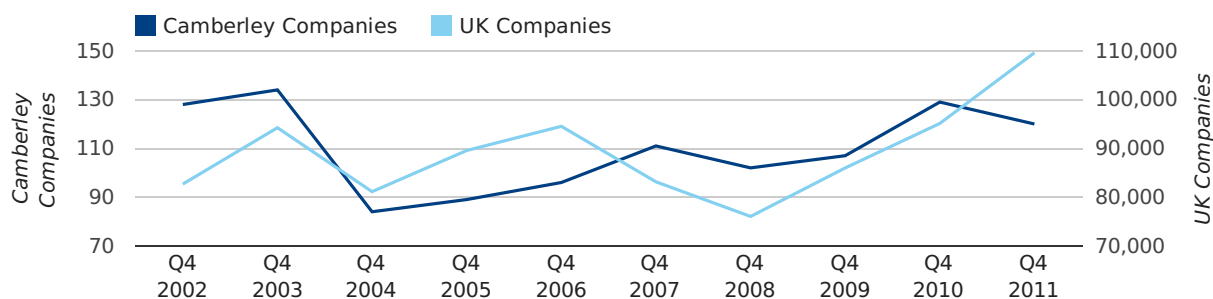
Quarterly Data (Q4 Oct-Dec 2011)

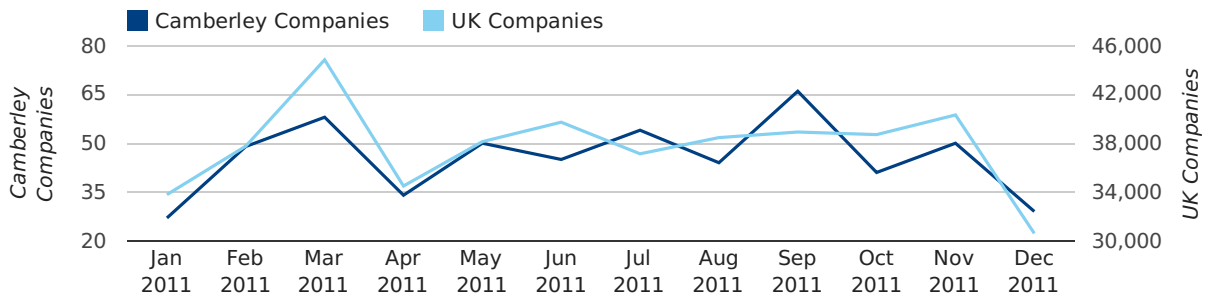
new companies by quarter

dissolved companies by year



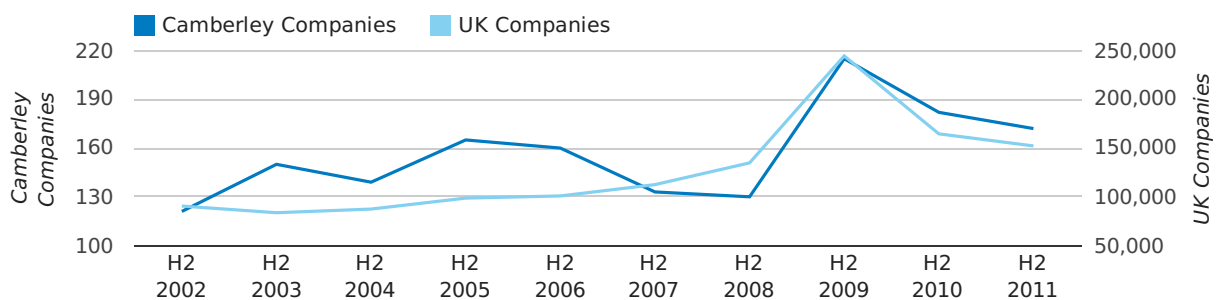
Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 172 companies were dissolved in Camberley. This figure is 5.5% lower than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Camberley occurred in 2009 when a total of 215 were closed.

dissolved companies by half year



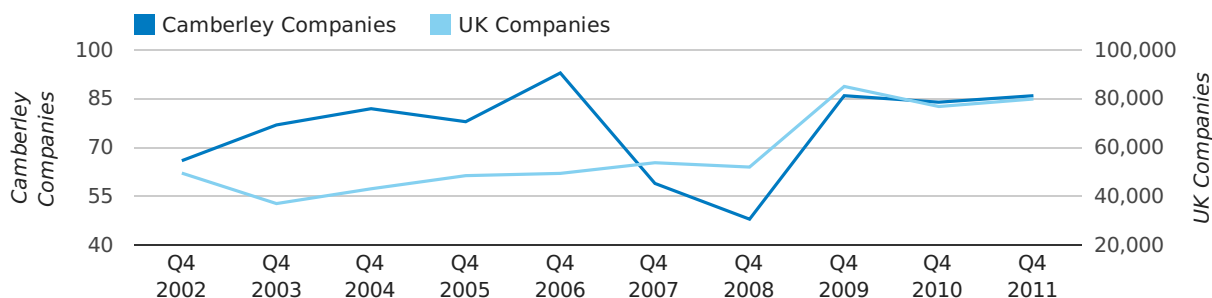
Quarterly Data (Q4 Oct-Dec 2011)

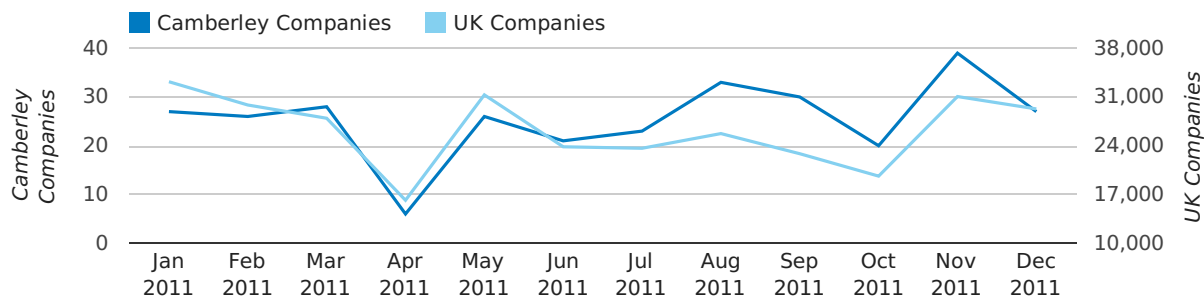
dissolved companies by quarter

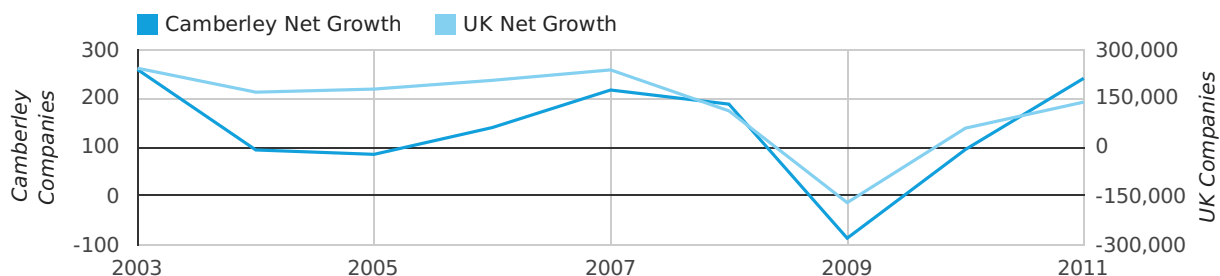
A total of 241 companies were added to the company register for Camberley in 2011. This number represents growth of 49.5% which compares favourably to the UK figure of 34.6%.

net growth by year

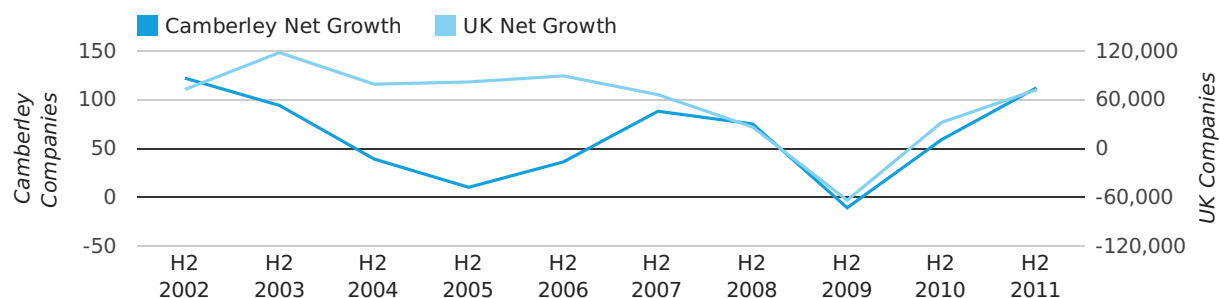


Half Year Data (Jul-Dec 2011)

net growth by half year



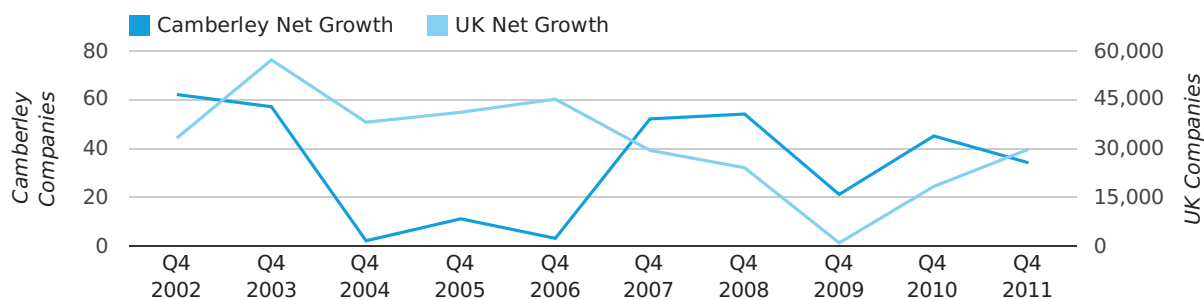

This represents a decrease of 24.4% on the same period last year.

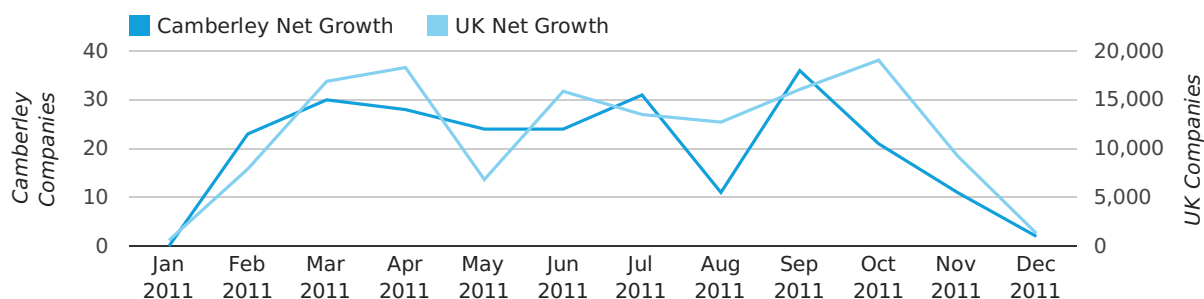

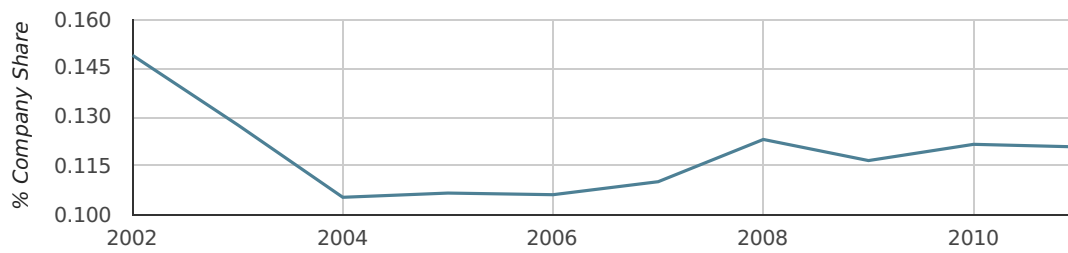

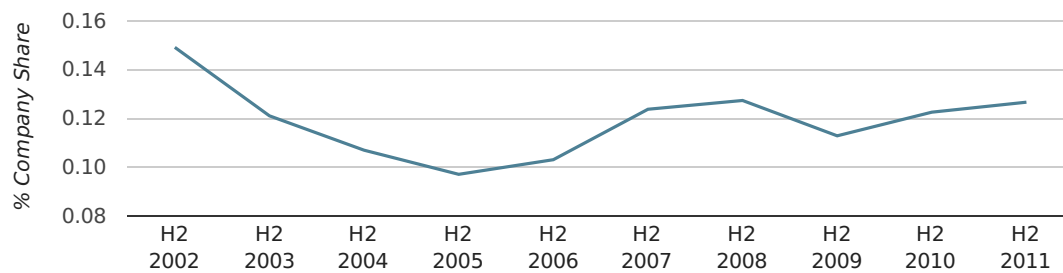

company share by half year

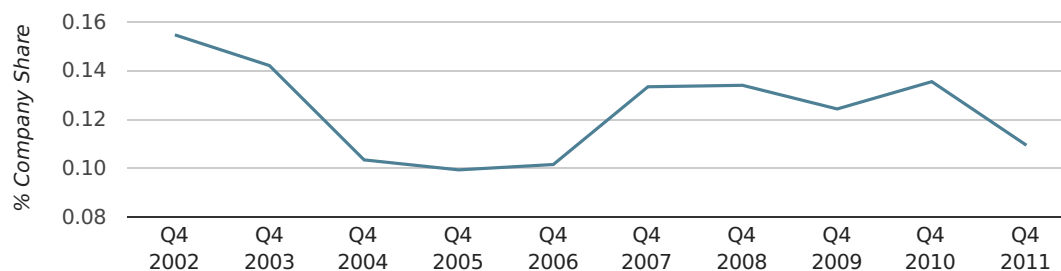

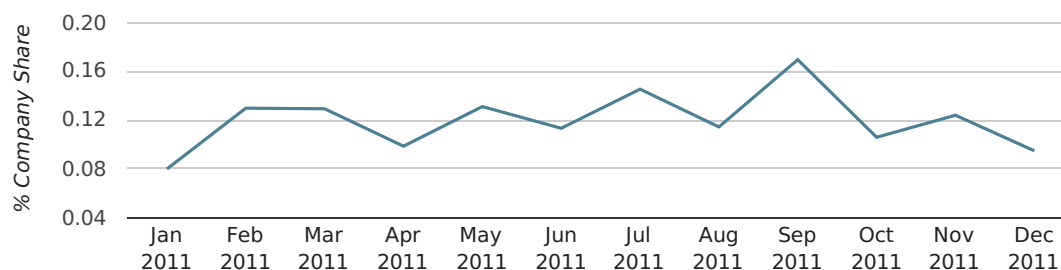

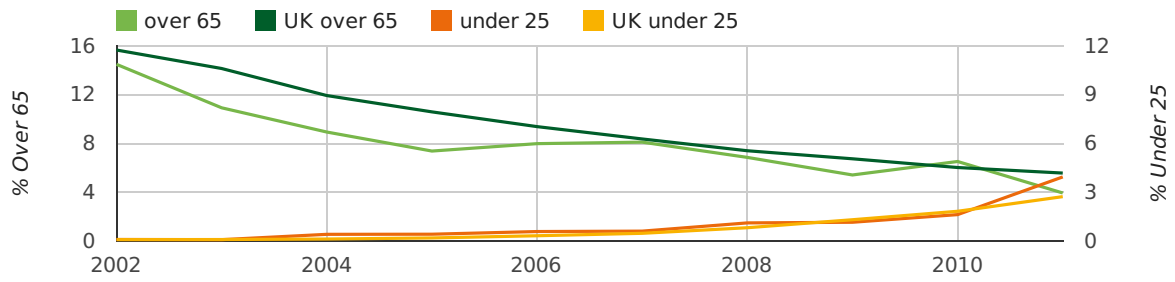

director age by year



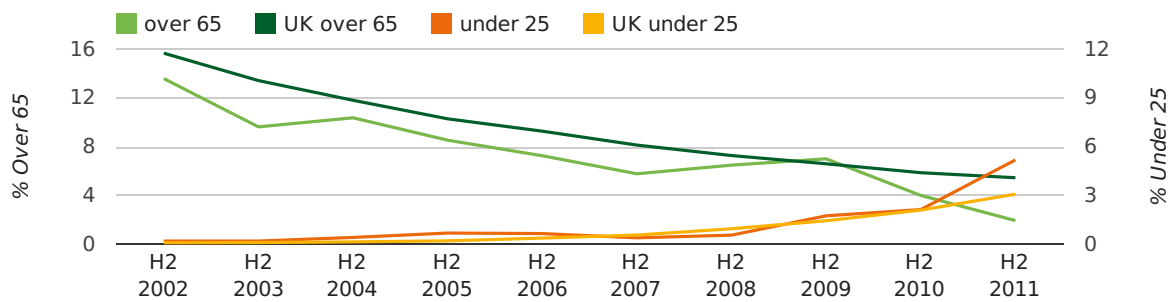
Half Year Data (Jul-Dec 2011)

director age by half year



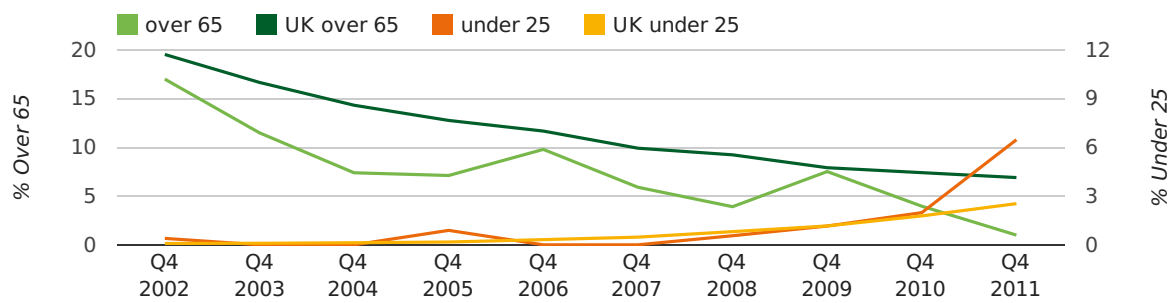

director age by quarter

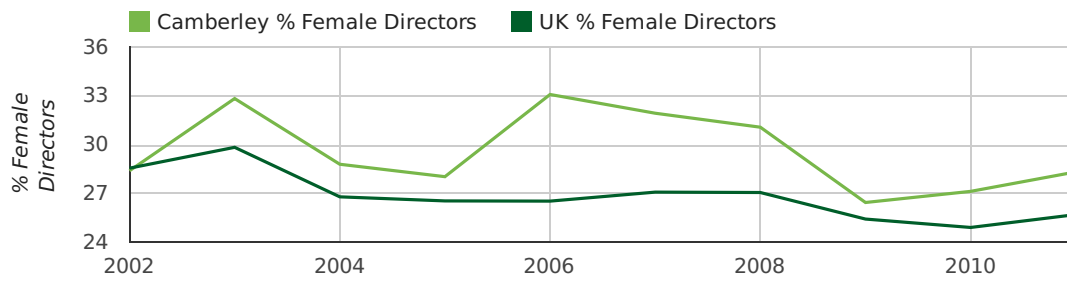


Annual Data (2011)

director gender by year

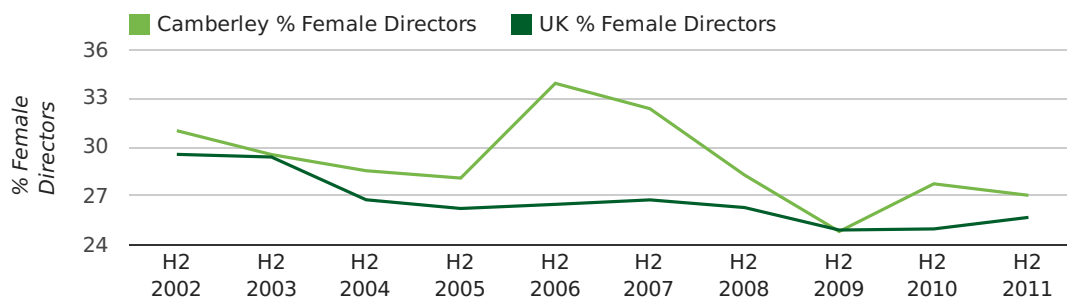


Half Year Data (Jul-Dec 2011)

director gender by half year

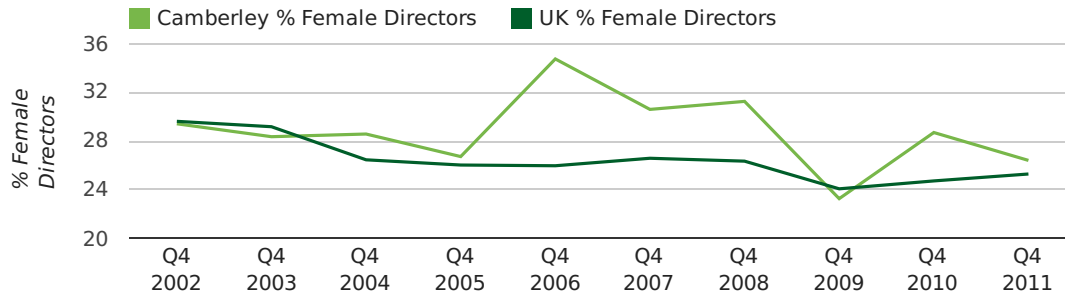


Quarterly Data (Q4 Oct-Dec 2011)
