
Q3 2011 saw a new record in company registrations in Cambridge when compared to any previous Q3.


RECORD YEAR





Net company growth for Cambridge during the third quarter of 2011 (Jul 2011 - Sep 2011) was 189 companies.









The percentage of directors over the age of 65 was 5.1% compared to the UK figure of 4.1%.


#### director age by quarter
