


The second half of 2011 saw a new record in company registrations in Canvey Island when compared to any previous second half year.

In the second half of 2011 a total of 95 companies were formed in Canvey Island. This figure is 53.2% higher than last year, which compares well to the UK wide figure of 14.0%.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Canvey Island when compared to any previous Q4.


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




A total of 31 companies were dissolved in Canvey Island during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 67 companies were added to the company register for Canvey Island in 2011. This number represents growth of 49.3% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Canvey Island during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 20 companies.








#### company share by half year





#### director age by year





#### director age by half year




#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
