The first half of 2012 saw a new record in company registrations in Cardiff when compared to any previous first half year.


The first half of 2012 was a record first half year for company registrations in Cardiff when compared to any half year in history.

In the first half of 2012 a total of 1,524 companies were formed in Cardiff. This figure is 23.1% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Cardiff occurred in 2012 when a total of 1,524 were formed.


Q2 2012 saw a new record in company registrations in Cardiff when compared to any previous Q2.

A total of 766 companies were registered in Cardiff during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 30.3% versus the same period last year (Q2 2011). This figure compares well to the UK as a whole, which saw an increase of 8.3% against the same period last year.


new companies by quarter

dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)





net growth by half year





This represents an increase of 60.8% on the same period last year.





company share by half year







director age by half year





The percentage of directors over the age of 65 was 2.0% compared to the UK figure of 3.3%.


director age by quarter

director gender by half year




Quarterly Data (Q2 Apr-Jun 2012)
