



A total of 266 companies were formed in Caterham in 2011. This total is 12.7% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Caterham when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Caterham when compared to any previous Q4.

new companies by quarter





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 46 companies were dissolved in Caterham during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 118 companies were added to the company register for Caterham in 2011. This number represents growth of 50.0% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Caterham during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 21 companies.


net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)
