




## Quarterly Data (Q2 Apr-Jun 2012)


#### new companies by month

#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)







#### net growth by quarter






company share by half year





#### director age by half year



The percentage of directors over the age of 65 was 6.9% compared to the UK figure of 3.3%.




#### director age by quarter
