

A total of 464 companies were formed in Cheadle in 2011. This total is 13.4% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Cheadle when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Cheadle when compared to any half year in history.

#### new companies by half year




#### Quarterly Data (Q4 Oct-Dec 2011)

Q4 2011 saw a new record in company registrations in Cheadle when compared to any previous Q4.


A total of 110 companies were registered in Cheadle during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 3.8% versus the same period last year (Q4 2010). This figure compares badly to the UK as a whole, which saw an increase of 15.3% against the same period last year.

#### new companies by quarter





dissolved companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 144 companies were dissolved in Cheadle. This figure is 10.0% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Cheadle occurred in 2009 when a total of 216 were closed.

#### dissolved companies by half year




A total of 72 companies were dissolved in Cheadle during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 167 companies were added to the company register for Cheadle in 2011. This number represents growth of 40.8% which compares favourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Cheadle during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 38 companies.

#### net growth by quarter






company share by year



company share by half year





#### director age by year




#### Half Year Data (Jul-Dec 2011)

The percentage of directors over the age of 65 was 1.6% compared to the UK figure of 4.1%.




#### director age by half year

#### director gender by year




## Half Year Data (Jul-Dec 2011)

The record second half year for female directors in Cheadle was 1860 when 42.9% of all directors were female.

25.2% of all director appointments in Cheadle in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.
