


#### new companies by quarter


Q1 2011 saw a new record in company closures in Chelmsford when compared to any previous Q1.

A total of 314 companies were dissolved in Chelmsford during the first quarter of 2011 (Jan 2011 - Mar 2011).

This figure is an increase of 32.5% versus the same period last year (Q1 2010). This figure compares poorly to the UK as a whole, which saw an increase of 10.0% against the same period last year.


#### dissolved companies by quarter

#### dissolved companies by month





This represents a decrease of 38.1% on the same period last year.









The percentage of directors over the age of 65 was 6.2% compared to the UK figure of 4.3%.


## director age by quarter
