• November 2011 saw a new record in company registrations in Chertsey when compared to any previous November.



#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 113 companies were formed in Chertsey. This figure is 56.9% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Chertsey occurred in 2009 when a total of 140 were formed.

#### new companies by half year




A total of 50 companies were registered in Chertsey during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




A total of 29 companies were dissolved in Chertsey during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 72 companies were added to the company register for Chertsey in 2011. This number represents growth of 39.3% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)




Net company growth for Chertsey during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 21 companies.

This represents an increase of 75.0% on the same period last year.








#### company share by half year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 44.4.

The percentage of directors over the age of 65 was 3.5% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)

#### director gender by half year


