

- November 2011 saw a new record in company closures in Chester when compared to any previous November.



A total of 898 companies were formed in Chester in 2011. This total is 14.4% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 464 companies were formed in Chester. This figure is 16.9% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Chester occurred in 2006 when a total of 678 were formed.

#### new companies by half year




A total of 233 companies were registered in Chester during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 370 companies were dissolved in Chester. This figure is 3.4% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Chester occurred in 2008 when a total of 1,573 were closed.

## dissolved companies by half year




A total of 189 companies were dissolved in Chester during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

#### dissolved companies by quarter




A total of 166 companies were added to the company register for Chester in 2011. This number represents growth of 21.1% which compares unfavourably to the UK figure of 34.6%.

This number is 73 companies higher than the previous year.




#### Half Year Data (Jul-Dec 2011)




Net company growth for Chester during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 44 companies.

This represents an increase of 63.0% on the same period last year.








#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 43.3.

#### director gender by year




## Half Year Data (Jul-Dec 2011)
