


The second half of 2011 saw a new record in company registrations in Chester Le Street when compared to any previous second half year.


Q4 2011 saw a new record in company registrations in Chester Le Street when compared to any previous Q4.






The second half of 2011 saw a new record in company closures in Chester Le Street when compared to any previous second half year.


Q4 2011 saw a new record in company closures in Chester Le Street when compared to any previous Q4.


dissolved companies by quarter


A total of 88 companies were added to the company register for Chester Le Street in 2011. This number represents growth of 56.8% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Chester Le Street during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 13 companies.

net growth by quarter






company share by year







director age by year





director age by half year



director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)

22.3% of all director appointments in Chester Le Street in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
