


## Quarterly Data (Q2 Apr-Jun 2011)

A total of 157 companies were registered in Chesterfield during the second quarter of 2011 (Apr 2011 - Jun 2011).








## Quarterly Data (Q2 Apr-Jun 2011)








company share by half year





#### director age by half year




