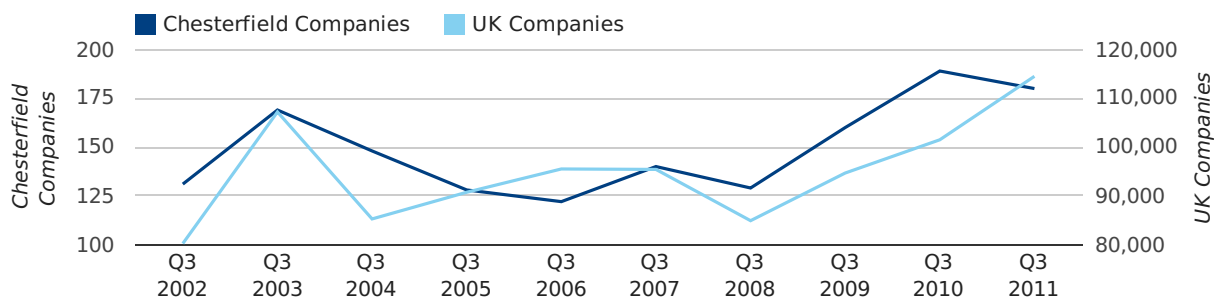
### Quarterly Data (Q3 Jul-Sep 2011)

A total of 180 companies were registered in Chesterfield during the third quarter of 2011 (Jul 2011 - Sep 2011).

This figure is a decrease of 4.8% versus the same period last year (Q3 2010). This figure compares badly to the UK as a whole, which saw an increase of 12.8% against the same period last year.

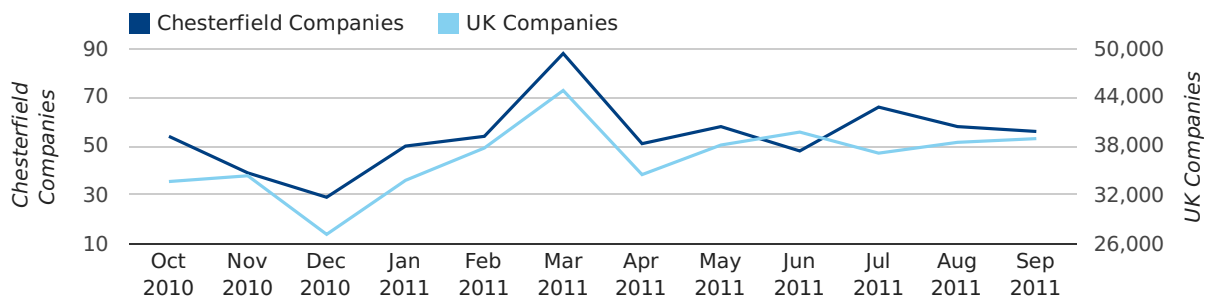

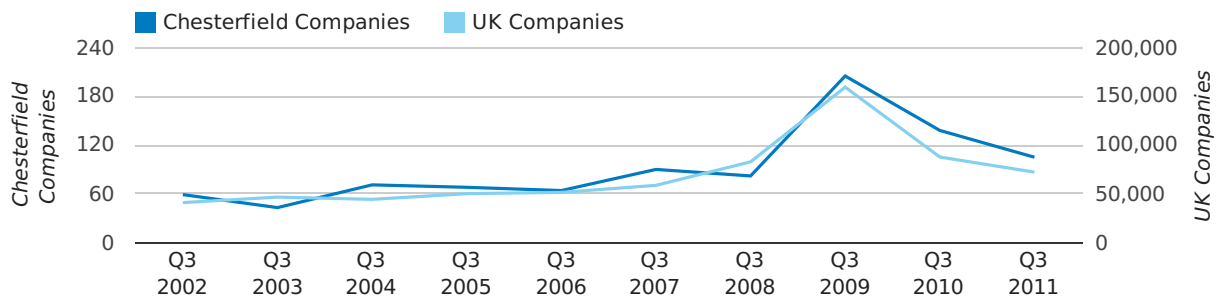
### Quarterly Data (Q3 Jul-Sep 2011)

A total of 105 companies were dissolved in Chesterfield during the third quarter of 2011 (Jul 2011 - Sep 2011).

This figure is a decrease of 23.9% versus the same period last year (Q3 2010). This figure compares well to the UK as a whole, which saw a decrease of 17.6% against the same period last year.

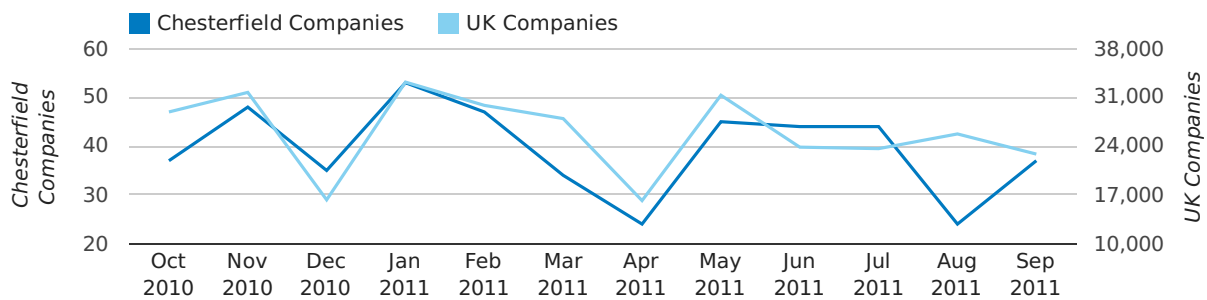
### dissolved companies by quarter

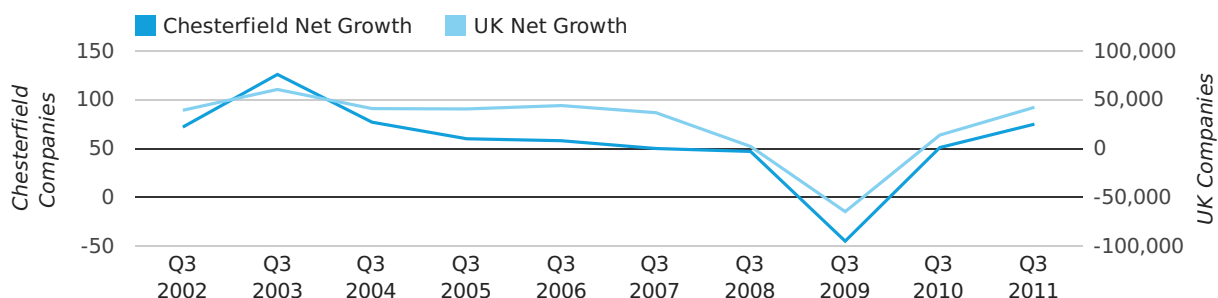
### Quarterly Data (Q3 Jul-Sep 2011)

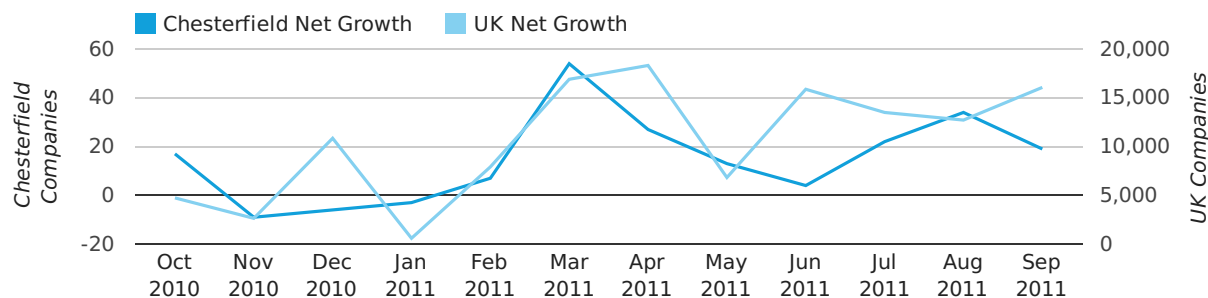
### net growth by quarter

### net growth by month



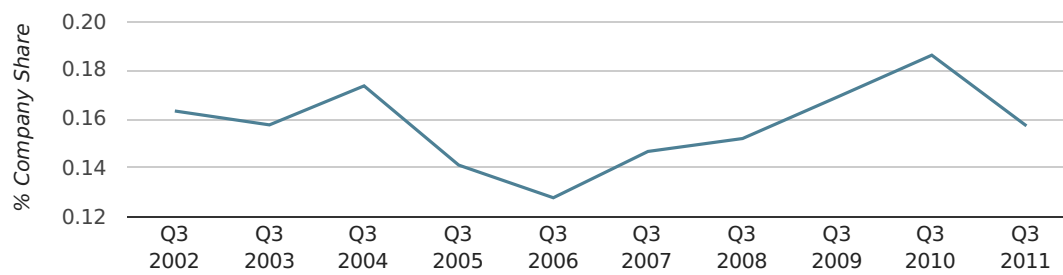

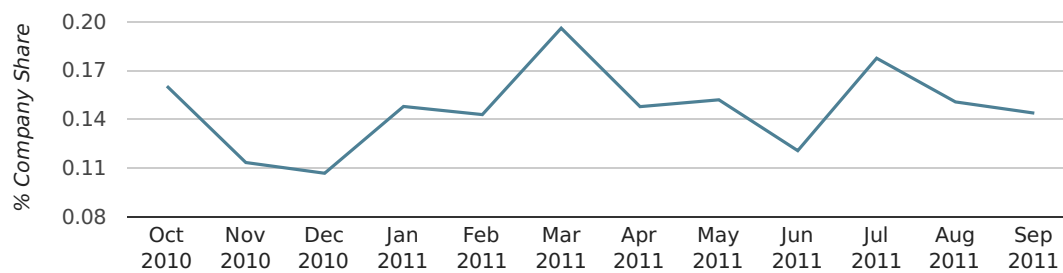

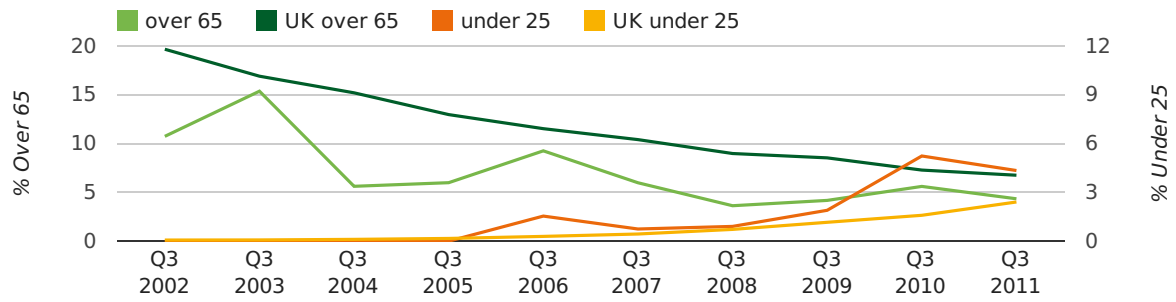
### Quarterly Data (Q3 Jul-Sep 2011)

#### director age by quarter

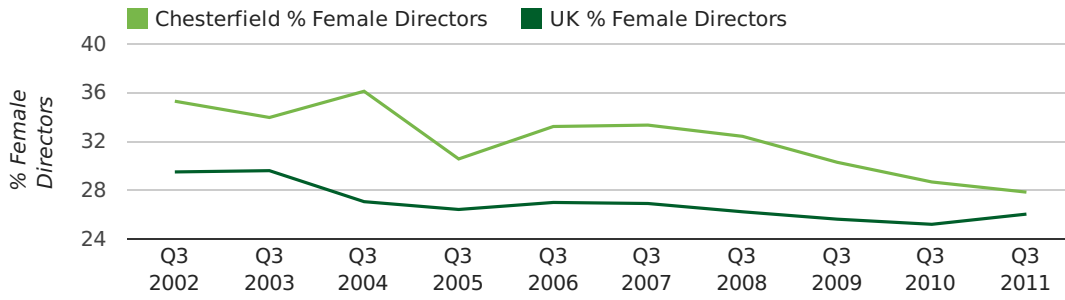


### Quarterly Data (Q3 Jul-Sep 2011)

The record third quarter for female directors in Chesterfield was in 1862 when 50.0% of all directors were female.

27.8% of all director appointments in Chesterfield in the third quarter of 2011 were female. This compares to a UK average of 26.0% for the same period.
