




The second half of 2011 saw a new record in company registrations in Chesterfield when compared to any previous second half year.




A total of 161 companies were registered in Chesterfield during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 110 companies were dissolved in Chesterfield during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 228 companies were added to the company register for Chesterfield in 2011. This number represents growth of 35.0% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Chesterfield during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 51 companies.








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


