


Half Year Data (Jul-Dec 2011)




A total of 27 companies were registered in Chigwell during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 21 companies were dissolved in Chigwell during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 33 companies were added to the company register for Chigwell in 2011. This number represents growth of 25.6% which compares unfavourably to the UK figure of 34.6%.

net growth by year



net growth by half year










company share by half year





director age by year





director age by half year




director age by quarter

director gender by year


