



A total of 27 companies were registered in Chipping Norton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).






A total of 48 companies were added to the company register for Chipping Norton in 2011. This number represents growth of 36.6% which compares favourably to the UK figure of 34.6%.



net growth by half year






company share by year







director age by year




director age by half year

director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)

32.3% of all director appointments in Chipping Norton in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
