

2011 was a record year for company registrations in Chislehurst when compared to any year in history.

A total of 174 companies were formed in Chislehurst in 2011. This total is 0.6% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.

# Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Chislehurst when compared to any previous second half year.

In the second half of 2011 a total of 87 companies were formed in Chislehurst. This figure is 26.1% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Chislehurst occurred in 2011 when a total of 87 were formed.

## new companies by half year




A total of 38 companies were registered in Chislehurst during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





## dissolved companies by year




# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 63 companies were dissolved in Chislehurst. This figure is 10.5% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Chislehurst occurred in 2009 when a total of 69 were closed.

## dissolved companies by half year




A total of 29 companies were dissolved in Chislehurst during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### dissolved companies by quarter


A total of 50 companies were added to the company register for Chislehurst in 2011. This number represents growth of 28.9% which compares unfavourably to the UK figure of 34.6%.




## Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Chislehurst during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 9 companies.

This represents a decrease of 18.2% on the same period last year.



#### net growth by month













#### director age by year





#### director age by half year



#### director gender by year




# Half Year Data (Jul-Dec 2011)

## director gender by half year


