

#### new companies by half year




#### Quarterly Data (Q2 Apr-Jun 2011)

A total of 136 companies were registered in Chorley during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### dissolved companies by half year





A total of 69 companies were dissolved in Chorley during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### net growth by half year















#### director age by half year





The percentage of directors over the age of 65 was 4.6% compared to the UK figure of 4.3%.


#### director age by quarter
