
The first half of 2012 was a record first half year for company registrations in Chorley when compared to any half year in history.

In the first half of 2012 a total of 301 companies were formed in Chorley. This figure is 3.4% higher than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Chorley occurred in 2012 when a total of 301 were formed.

#### new companies by half year




### Quarterly Data (Q2 Apr-Jun 2012)

A total of 127 companies were registered in Chorley during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is a decrease of 6.6% versus the same period last year (Q2 2011). This figure compares badly to the UK as a whole, which saw an increase of 8.3% against the same period last year.



In the first half of 2012 a total of 184 companies were dissolved in Chorley. This figure is 22.7% higher than last year, which compares badly to the UK wide change of -8.9%.

#### dissolved companies by half year




### Quarterly Data (Q2 Apr-Jun 2012)

A total of 104 companies were dissolved in Chorley during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 50.7% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.



#### net growth by half year















#### director age by half year





The percentage of directors over the age of 65 was 3.0% compared to the UK figure of 3.3%.


#### director age by quarter
