


Quarterly Data (Q2 Apr-Jun 2012)

dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)








company share by half year





director age by half year



The percentage of directors under the age of 25 was 9.1% compared to the UK figure of 5.2%.


The percentage of directors over the age of 65 was 10.1% compared to the UK figure of 3.3%.

28.0% of all director appointments in Cirencester in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.


director gender by half year
