

new companies by year




Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 45 companies were registered in Clitheroe during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 35 companies were dissolved in Clitheroe during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 120 companies were added to the company register for Clitheroe in 2011. This number represents growth of 64.2% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Clitheroe during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 10 companies.



net growth by month






company share by half year





director age by year





director age by half year



director gender by year



director gender by half year


