

2011 was a record year for company registrations in Corby when compared to any year in history.

A total of 246 companies were formed in Corby in 2011. This total is 33.7% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 115 companies were formed in Corby. This figure is 23.7% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Corby occurred in 2009 when a total of 116 were formed.

#### new companies by half year




A total of 49 companies were registered in Corby during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 72 companies were dissolved in Corby. This figure is 16.1% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Corby occurred in 2009 when a total of 117 were closed.

#### dissolved companies by half year




A total of 37 companies were dissolved in Corby during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### dissolved companies by quarter


A total of 87 companies were added to the company register for Corby in 2011. This number represents growth of 47.3% which compares favourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)




Net company growth for Corby during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 12 companies.

This represents a decrease of 20.0% on the same period last year.








#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 42.6.

The percentage of directors over the age of 65 was 0.0% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)

#### director gender by half year


