

A total of 103 companies were formed in Corsham in 2011. This total is 19.8% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Corsham when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Corsham when compared to any half year in history.

Quarterly Data (Q4 Oct-Dec 2011)


Q4 2011 saw a new record in company registrations in Corsham when compared to any previous Q4.


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Corsham when compared to any previous Q4.




A total of 58 companies were added to the company register for Corsham in 2011. This number represents growth of 67.4% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Corsham during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 17 companies.


net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
