

The second half of 2011 saw a new record in company registrations in Coulsdon when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Coulsdon when compared to any half year in history.


Q4 2011 saw a new record in company registrations in Coulsdon when compared to any previous Q4.


#### new companies by quarter



The second half of 2011 saw a new record in company closures in Coulsdon when compared to any previous second half year.


The second half of 2011 was a record second half year for company closures in Coulsdon when compared to any half year in history.

## dissolved companies by half year




#### Quarterly Data (Q4 Oct-Dec 2011)


A total of 24 companies were added to the company register for Coulsdon in 2011. This number represents growth of 14.5% which compares unfavourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Q4 2011 saw a new record in net growth in Coulsdon when compared to any previous Q4.

This represents an increase of 350.0% on the same period last year.





#### company share by year




#### company share by half year





#### director age by half year




## director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)

#### director gender by half year


