
The first half of 2012 was a record first half year for company registrations in Coulsdon when compared to any half year in history.

Q2 2012 saw a new record in company registrations in Coulsdon when compared to any previous Q2.


Q2 2012 was a record quarter for company registrations in Coulsdon when compared to any quarter in history.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)






Q2 2012 saw a new record in net growth in Coulsdon when compared to any previous Q2.


net growth by quarter

net growth by month



company share by half year







The percentage of directors over the age of 65 was 5.6% compared to the UK figure of 3.3%.


director age by quarter
