
The first half of 2011 was a record first half year for company registrations in Coventry when compared to any half year in history.

Q2 2011 saw a new record in company registrations in Coventry when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Coventry when compared to any quarter in history.

new companies by quarter





new companies by month





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





net growth by half year







company share by half year







director age by half year






director age by quarter
