

new companies by year




Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 26 companies were registered in Cranbrook during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 15 companies were dissolved in Cranbrook during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 44 companies were added to the company register for Cranbrook in 2011. This number represents growth of 33.6% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Cranbrook during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 11 companies.


net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


