

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Crediton when compared to any previous second half year.

In the second half of 2011 a total of 65 companies were formed in Crediton. This figure is 27.5% higher than last year, which compares well to the UK wide figure of 14.0%.

#### new companies by half year




A total of 29 companies were registered in Crediton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




## Half Year Data (Jul-Dec 2011)

## dissolved companies by half year




A total of 10 companies were dissolved in Crediton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 69 companies were added to the company register for Crediton in 2011. This number represents growth of 69.0% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Crediton during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 19 companies.

This represents an increase of 90.0% on the same period last year.



#### net growth by month








### company share by half year





#### director age by year





#### director age by half year




## director age by quarter

#### director gender by year




# Half Year Data (Jul-Dec 2011)
