Q1 2011 saw a new record in company registrations in Dagenham when compared to any previous Q1.


Q1 2011 was a record quarter for company registrations in Dagenham when compared to any quarter in history.




dissolved companies by quarter

dissolved companies by month










company share by quarter


Quarterly Data (Q1 Jan-Mar 2011)
