
The first half of 2011 was a record first half year for company registrations in Dagenham when compared to any half year in history.

new companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)



net growth by half year



Net company growth for Dagenham during the second quarter of 2011 (Apr 2011 - Jun 2011) was 92 companies.



net growth by month



company share by half year







director age by half year











The record first half year for female directors in Dagenham was 1857 when 40.0% of all directors were female.
