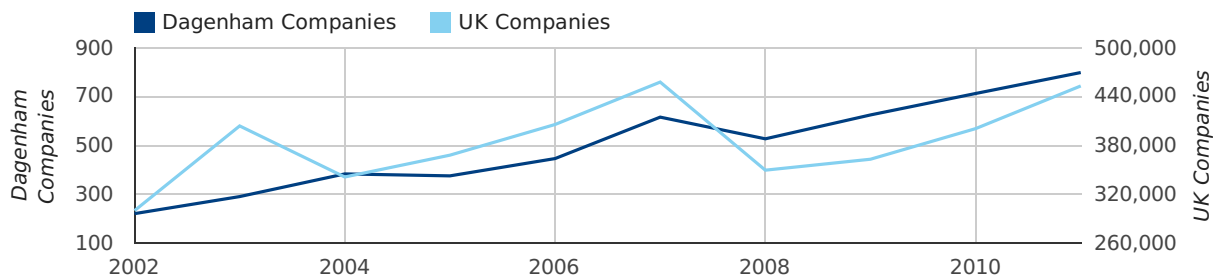
Annual Data (2011)

2011 was a record year for company registrations in Dagenham when compared to any year in history.

A total of 798 companies were formed in Dagenham in 2011. This total is 12.1% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

Half Year Data (Jul-Dec 2011)

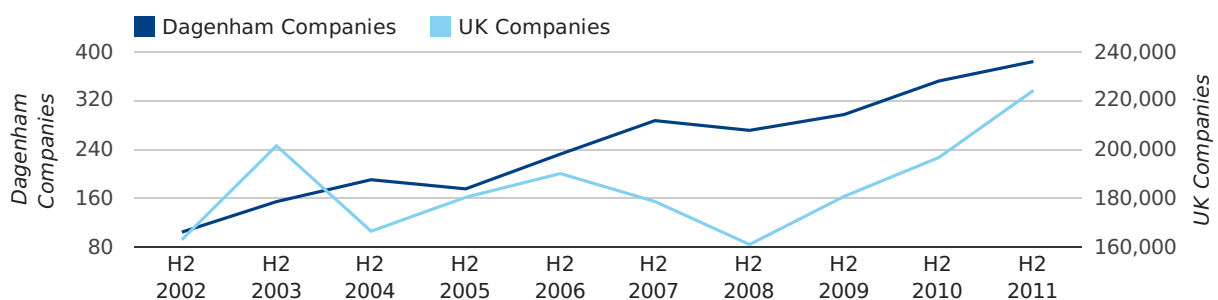
The second half of 2011 saw a new record in company registrations in Dagenham when compared to any previous second half year.

In the second half of 2011 a total of 384 companies were formed in Dagenham. This figure is 9.1% higher than last year, which compares badly to the UK wide figure of 14.0%.

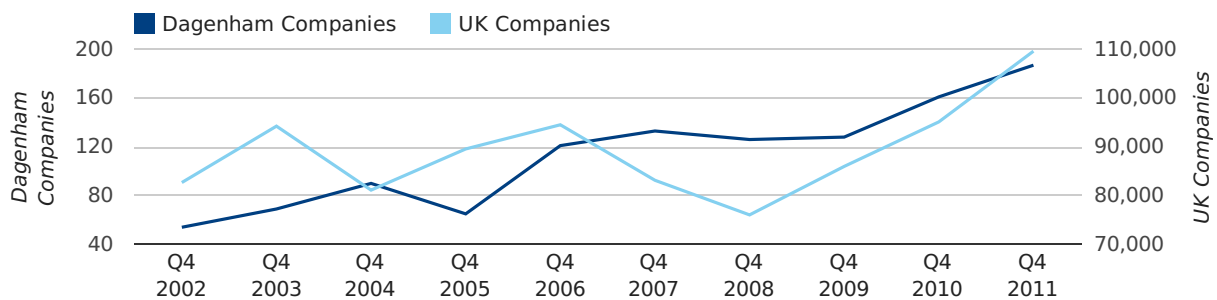
Q4 2011 saw a new record in company registrations in Dagenham when compared to any previous Q4.

new companies by quarter



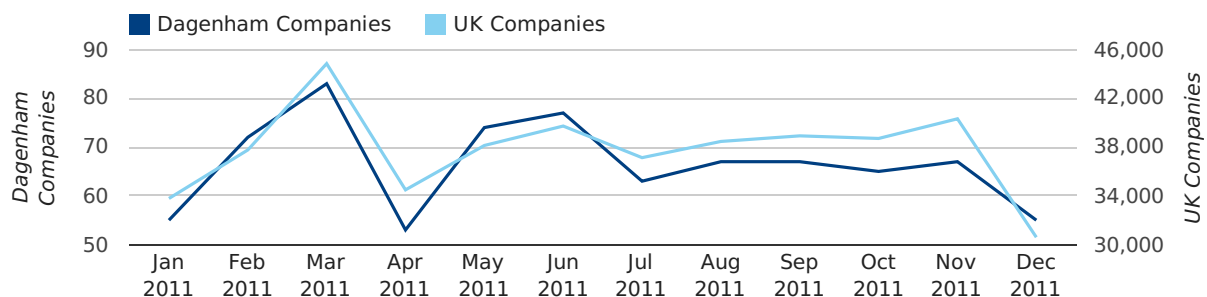

new companies by month



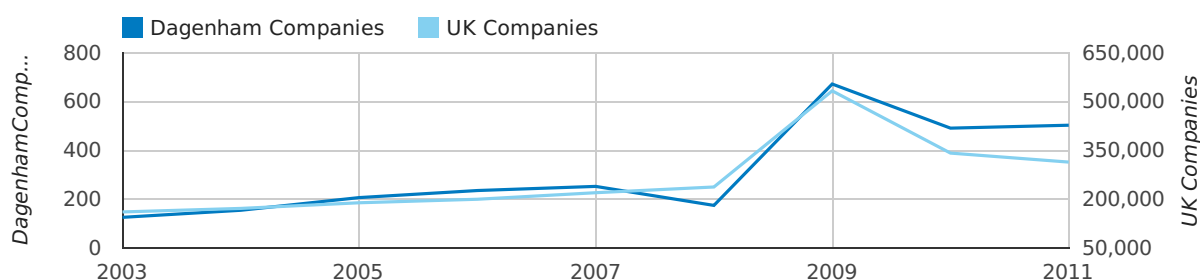

dissolved companies by year



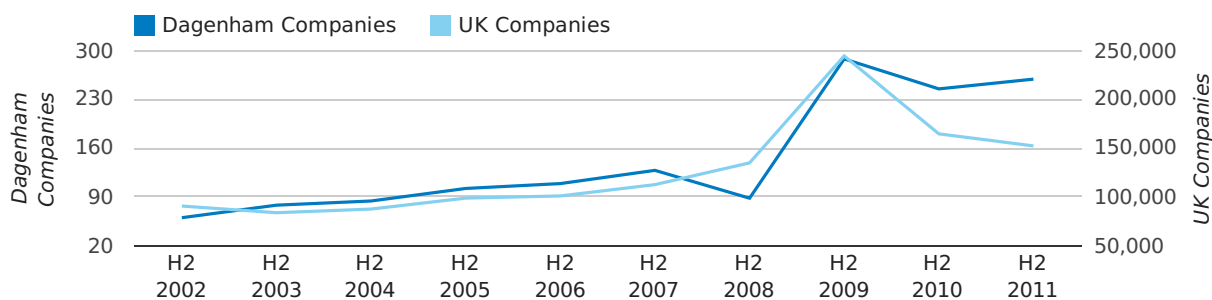
Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 259 companies were dissolved in Dagenham. This figure is 5.7% higher than last year, which compares badly to the UK wide change of -7.5%.

dissolved companies by half year



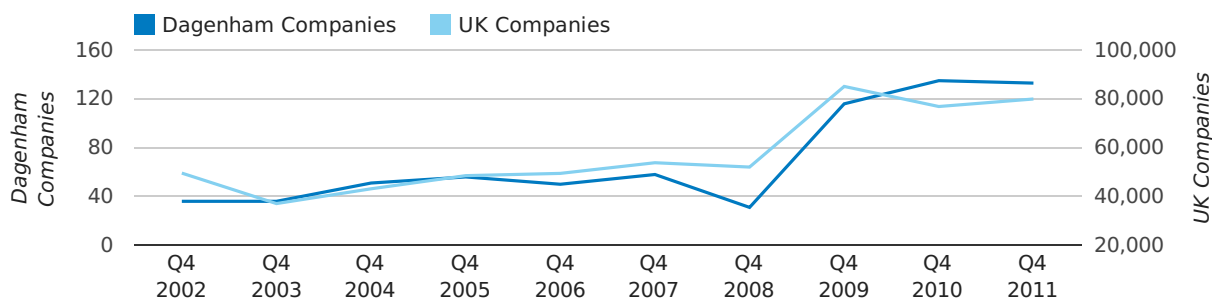
Quarterly Data (Q4 Oct-Dec 2011)

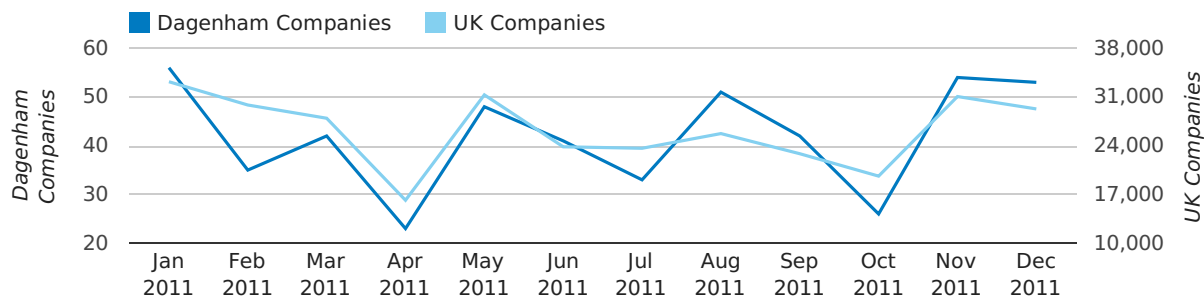
dissolved companies by quarter

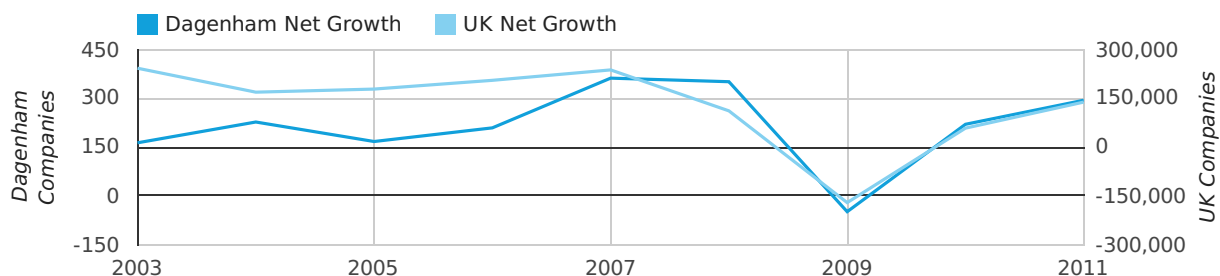
A total of 294 companies were added to the company register for Dagenham in 2011. This number represents growth of 41.3% which compares favourably to the UK figure of 34.6%.

net growth by year

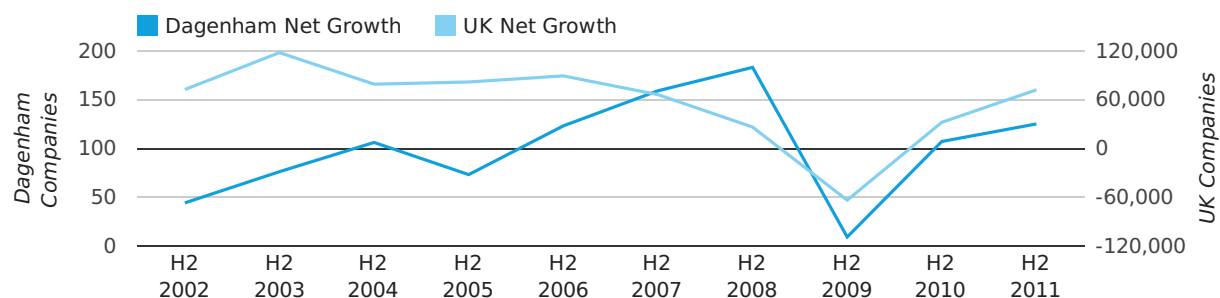


Half Year Data (Jul-Dec 2011)

net growth by half year



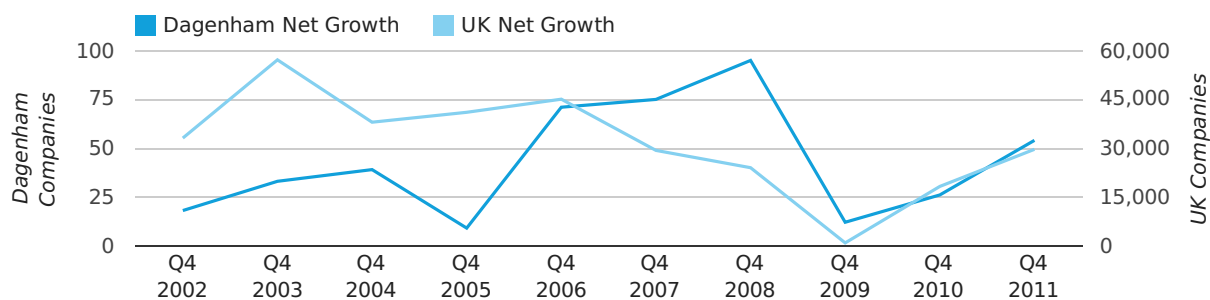

This represents an increase of 107.7% on the same period last year.

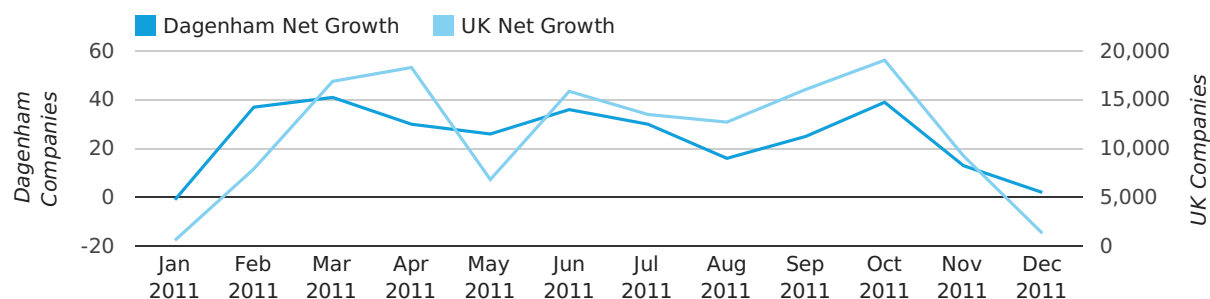

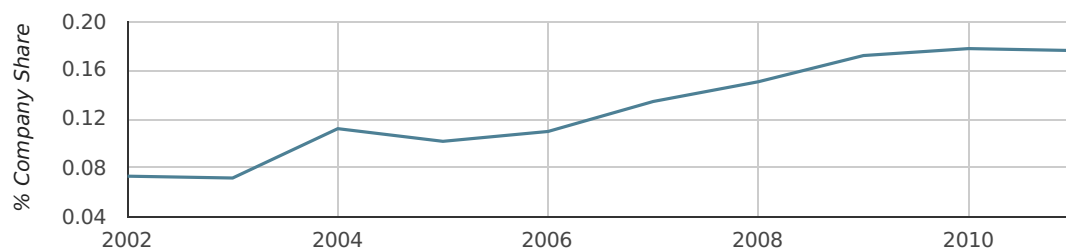

company share by year

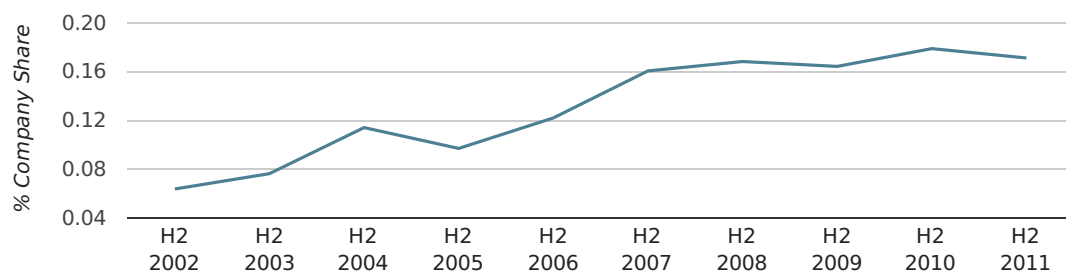

company share by half year

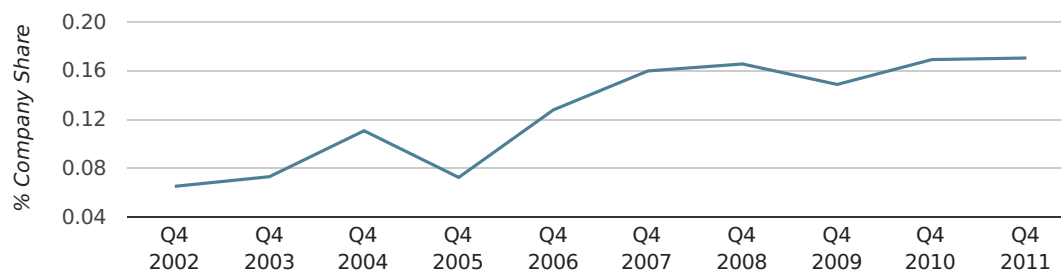

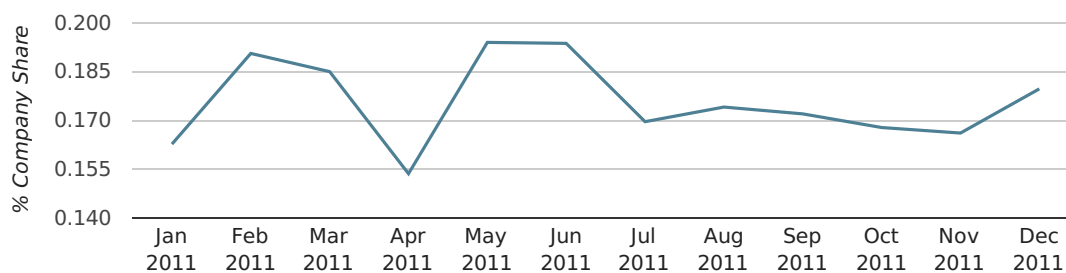
company share by quarter

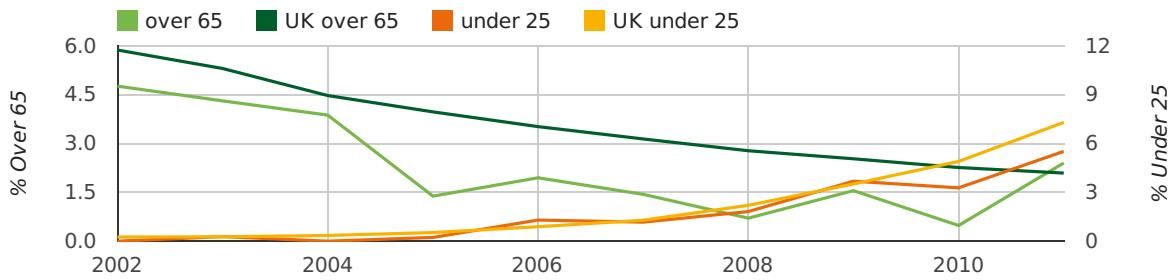

director age by year



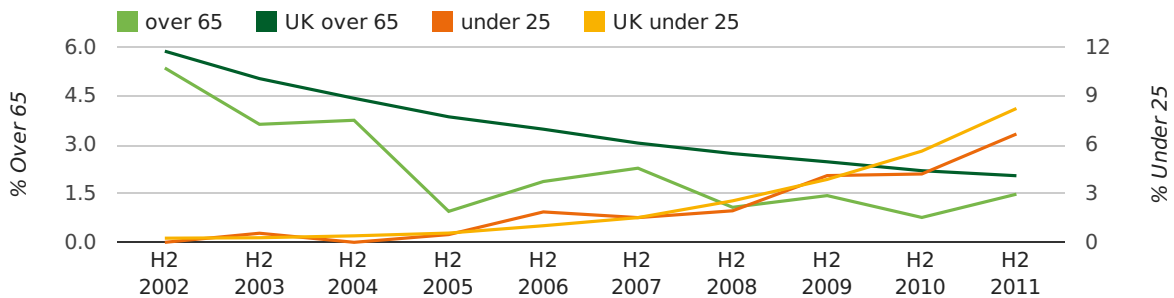

director age by half year



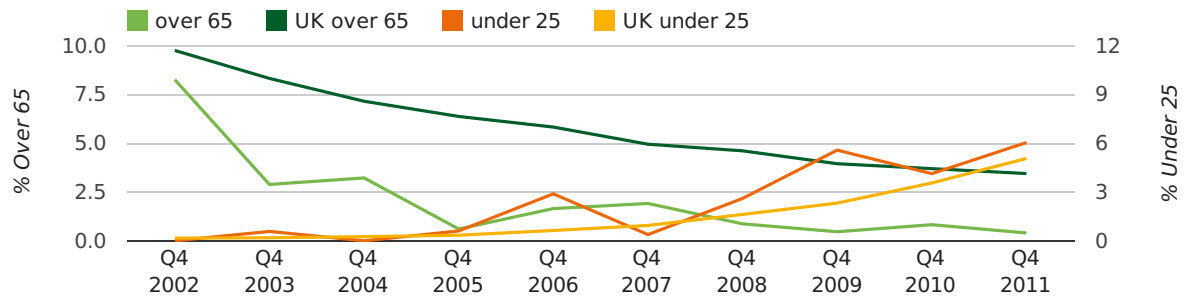

director age by quarter

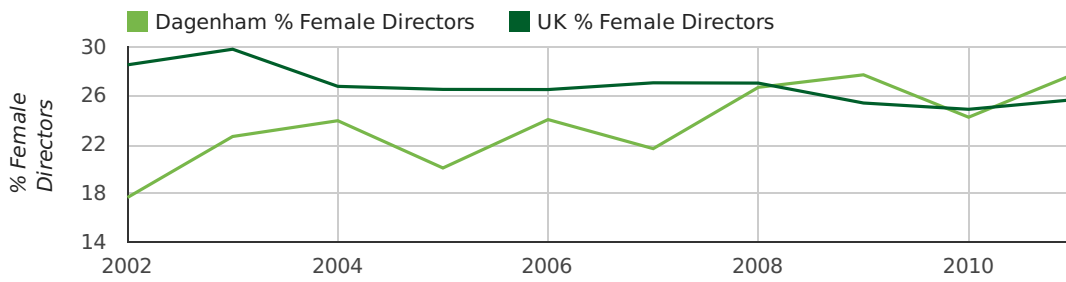


Annual Data (2011)

director gender by year

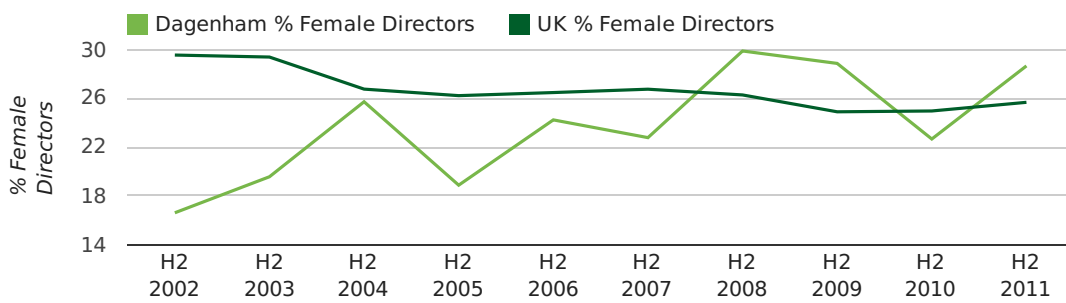


Half Year Data (Jul-Dec 2011)

director gender by half year

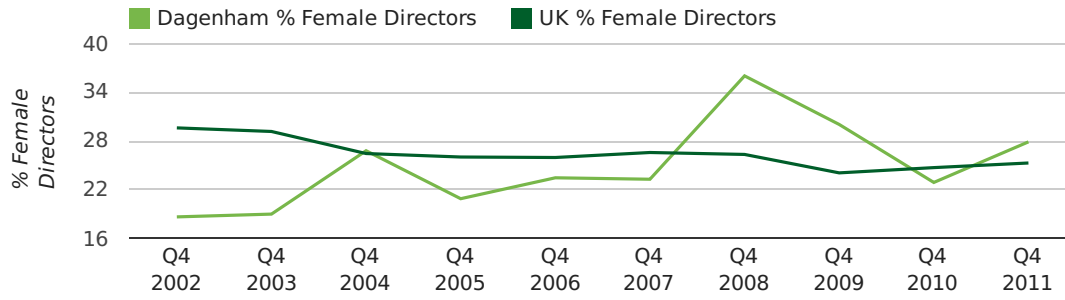


Quarterly Data (Q4 Oct-Dec 2011)
