
















## Quarterly Data (Q3 Jul-Sep 2011)

The average age of a director in the third quarter of 2011 was 41.3.

The percentage of directors under the age of 25 was 4.1% compared to the UK figure of 4.0%.

The percentage of directors over the age of 65 was 2.8% compared to the UK figure of 4.1%.

The record third quarter for female directors in Dartford was in 1862 when 50.0% of all directors were female.
