The first half of 2011 was a record first half year for company registrations in Derby when compared to any half year in history.

In the first half of 2011 a total of 856 companies were formed in Derby. This figure is 12.2% higher than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Derby occurred in 2011 when a total of 856 were formed.


Q2 2011 saw a new record in company registrations in Derby when compared to any previous Q2.

new companies by quarter





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





net growth by half year





This represents an increase of 132.8% on the same period last year.





company share by half year







director age by half year






director age by quarter
