
The first half of 2012 saw a new record in company registrations in Derby when compared to any previous first half year.

In the first half of 2012 a total of 991 companies were formed in Derby. This figure is 15.8% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Derby occurred in 2012 when a total of 991 were formed.


## Quarterly Data (Q2 Apr-Jun 2012)

A total of 466 companies were registered in Derby during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 11.5% versus the same period last year (Q2 2011). This figure compares equally to the UK as a whole, which saw an increase of 8.3% against the same period last year.



#### new companies by month



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)







Net company growth for Derby during the second quarter of 2012 (Apr 2012 - Jun 2012) was 190 companies.





company share by half year






## Half Year Data (Jan-Jun 2012)

The percentage of directors under the age of 25 was 6.8% compared to the UK figure of 5.2%.


The percentage of directors over the age of 65 was 1.6% compared to the UK figure of 3.3%.

The record first half year for female directors in Derby was 1861 when 40.0% of all directors were female.

26.1% of all director appointments in Derby in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Derby was in 1866 when 66.7% of all directors were female.

25.2% of all director appointments in Derby in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
