
The first half of 2012 saw a new record in company registrations in Derbyshire when compared to any previous first half year.

In the first half of 2012 a total of 2,352 companies were formed in Derbyshire. This figure is 11.7% higher than last year, which compares equally to the UK wide figure of 10.7%.

The highest total for a first half year in Derbyshire occurred in 2012 when a total of 2,352 were formed.


# Quarterly Data (Q2 Apr-Jun 2012)



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)












company share by half year





#### director age by half year





The percentage of directors over the age of 65 was 2.9% compared to the UK figure of 3.3%.


#### director age by quarter
