

new companies by year




Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 67 companies were formed in Devizes. This figure is 48.9% higher than last year, which compares well to the UK wide figure of 14.0%.

new companies by half year




A total of 38 companies were registered in Devizes during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Devizes when compared to any previous Q4.


dissolved companies by quarter


A total of 52 companies were added to the company register for Devizes in 2011. This number represents growth of 53.1% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




net growth by quarter

net growth by month





company share by year




company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
