The first half of 2012 saw a new record in company registrations in Dewsbury when compared to any previous first half year.

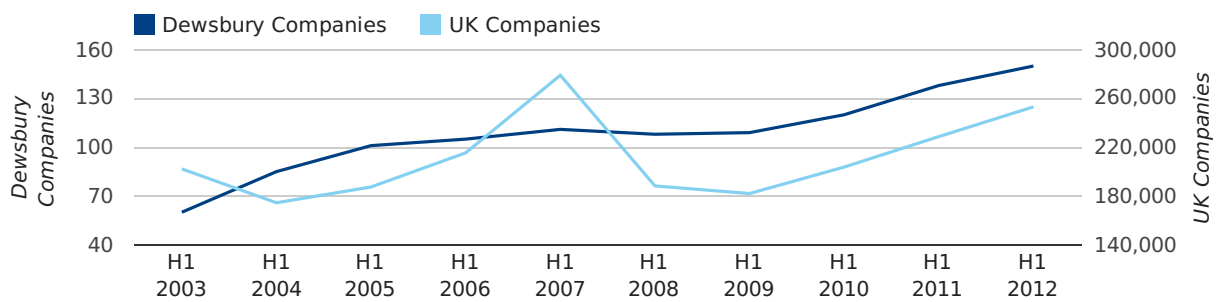
The first half of 2012 was a record first half year for company registrations in Dewsbury when compared to any half year in history.

In the first half of 2012 a total of 150 companies were formed in Dewsbury. This figure is 8.7% higher than last year, which compares badly to the UK wide figure of 10.7%.

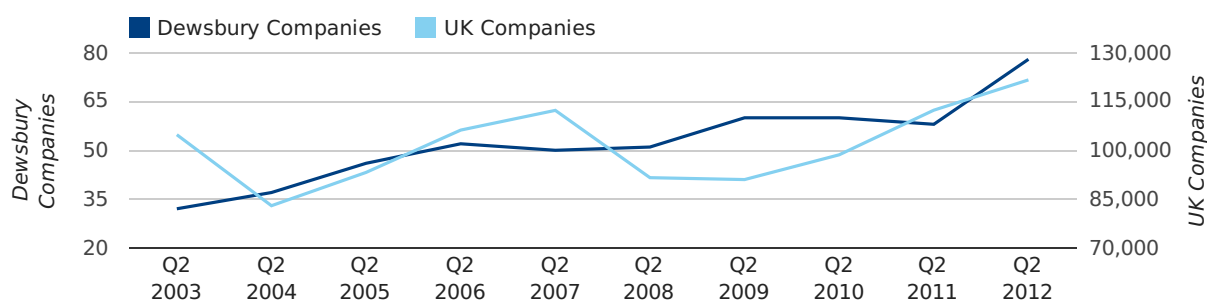
Q2 2012 saw a new record in company registrations in Dewsbury when compared to any previous Q2.

new companies by quarter



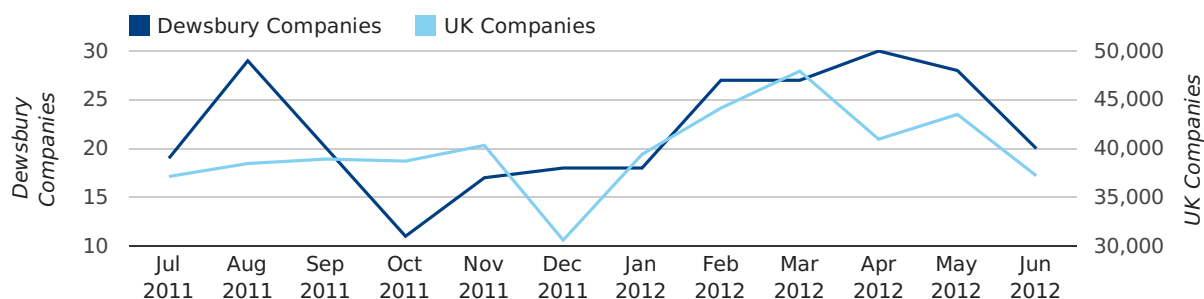

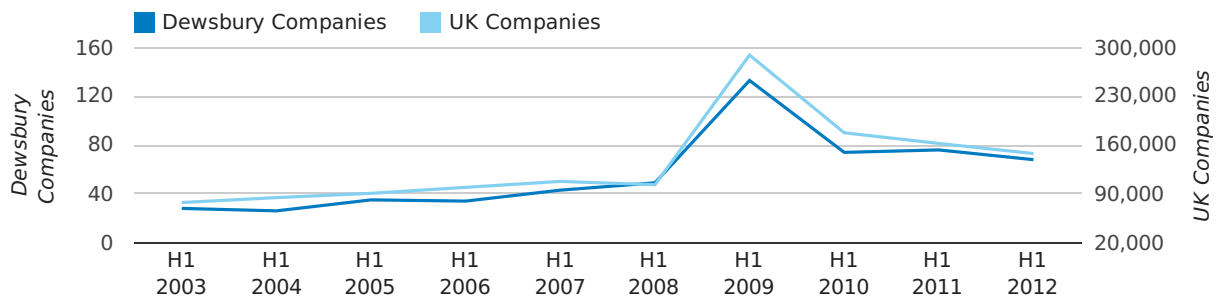
Half Year Data (Jan-Jun 2012)

dissolved companies by half year



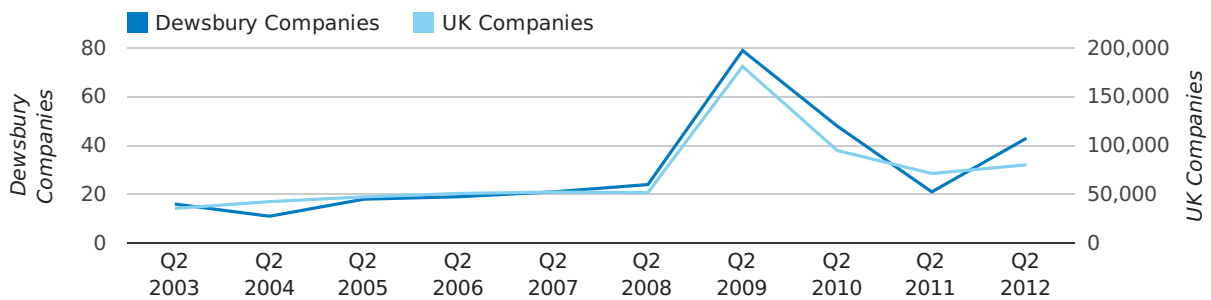
Quarterly Data (Q2 Apr-Jun 2012)

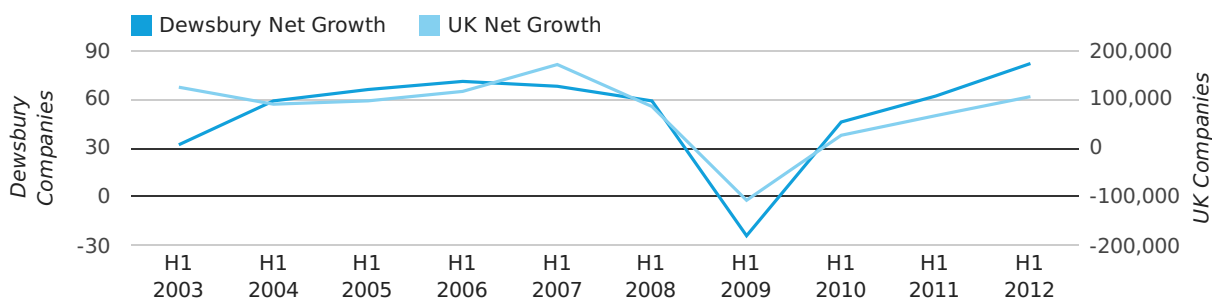
The first half of 2012 saw a new record in net growth in Dewsbury when compared to any previous first half year.

net growth by half year



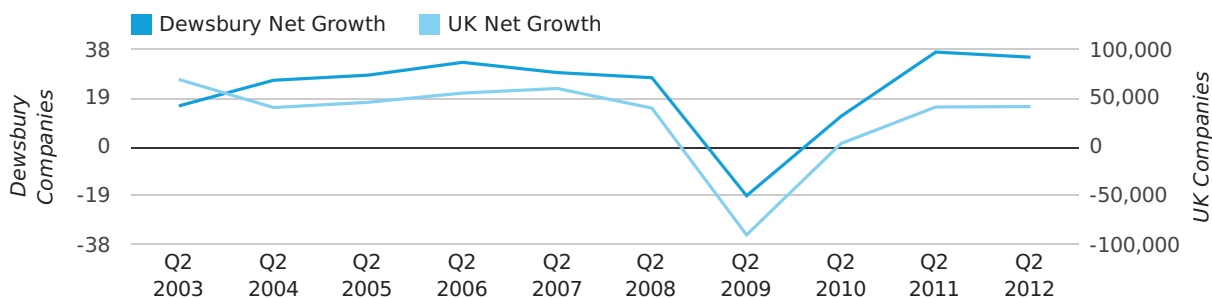

net growth by quarter

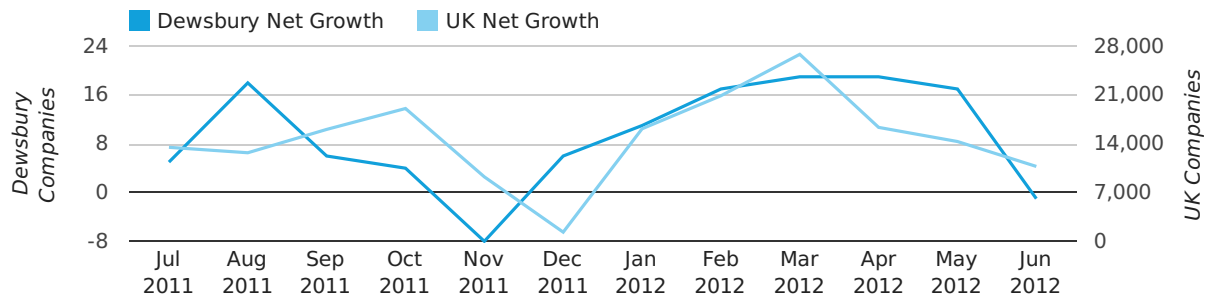

net growth by month



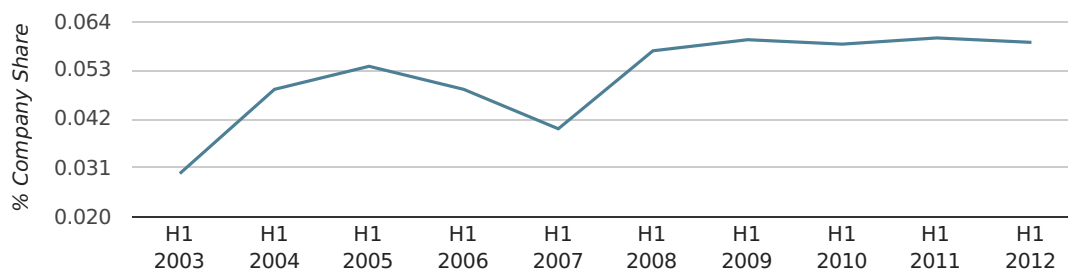

company share by half year

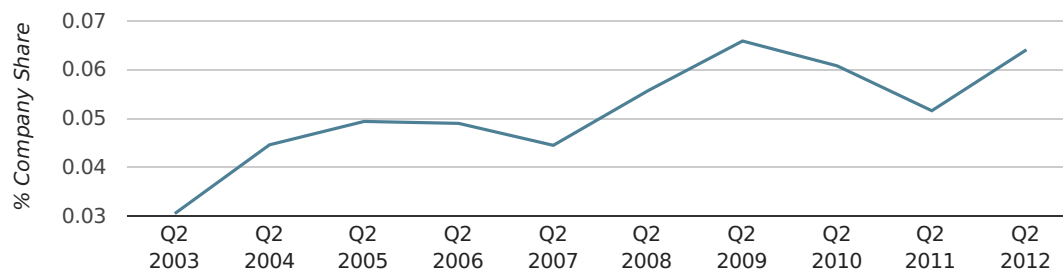

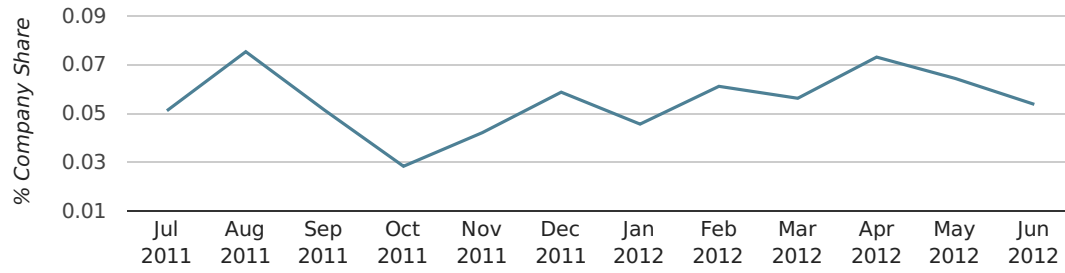

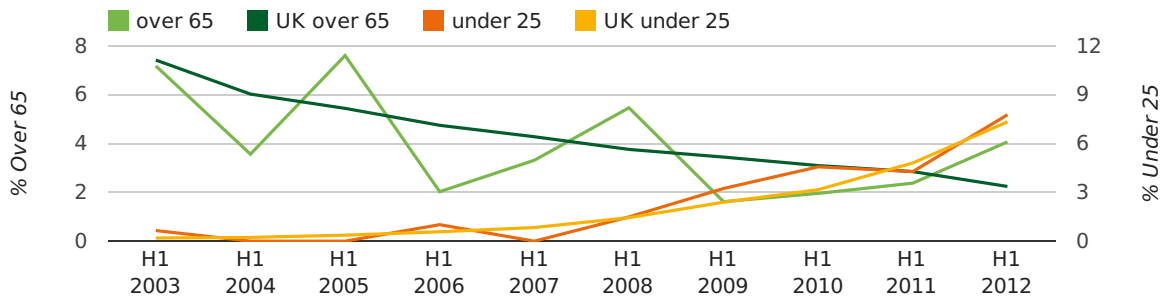

director age by half year



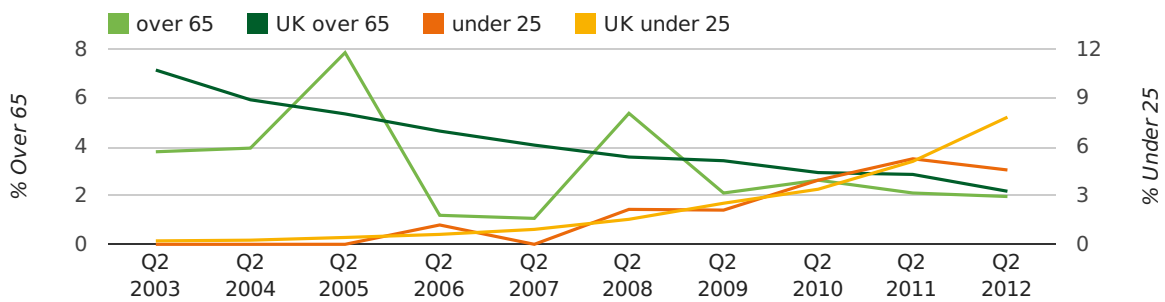

director age by quarter

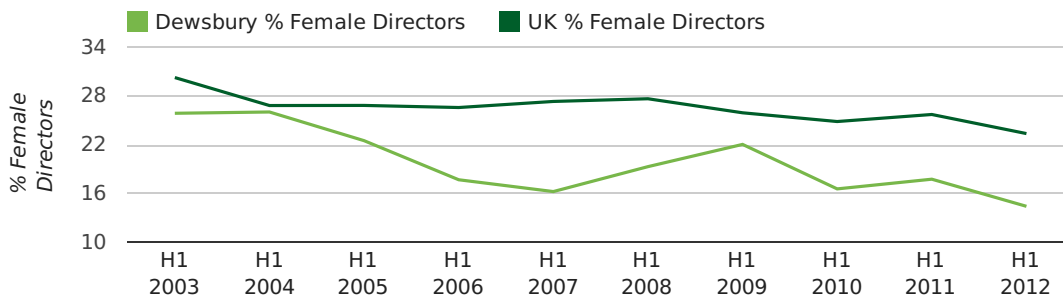


Half Year Data (Jan-Jun 2012)

director gender by half year

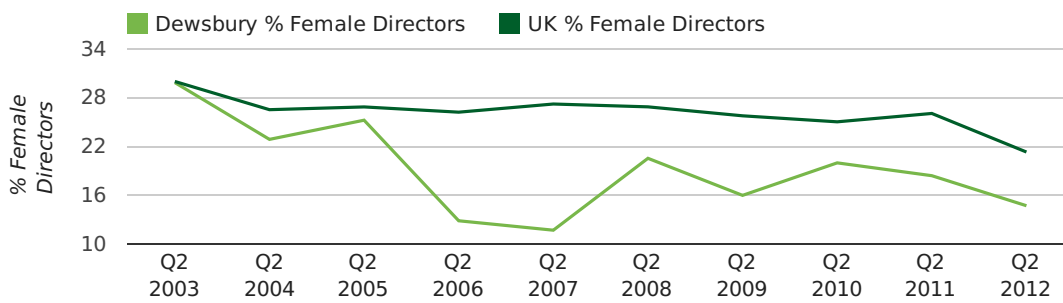


Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Dewsbury was in 1866 when 66.7% of all directors were female.

14.7% of all director appointments in Dewsbury in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
