

The second half of 2011 saw a new record in company registrations in Didcot when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Didcot when compared to any half year in history.

#### new companies by half year




# Quarterly Data (Q4 Oct-Dec 2011)





In the second half of 2011 a total of 44 companies were dissolved in Didcot. This figure is 29.4% higher than last year, which compares badly to the UK wide change of -7.5%.




Q4 2011 saw a new record in company closures in Didcot when compared to any previous Q4.




A total of 65 companies were added to the company register for Didcot in 2011. This number represents growth of 59.6% which compares favourably to the UK figure of 34.6%.

#### net growth by year




## Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Didcot during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 7 companies.

#### net growth by quarter






company share by year







#### director age by year








## director age by quarter

## director gender by year




# Half Year Data (Jul-Dec 2011)
