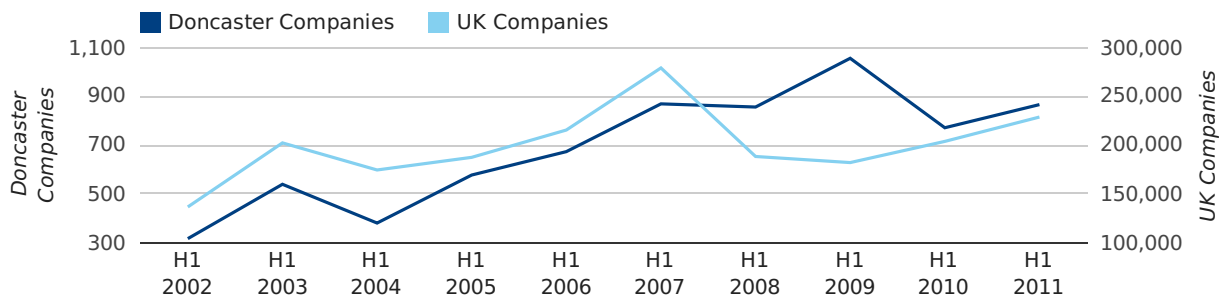
### Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 866 companies were formed in Doncaster. This figure is 12.3% higher than last year, which compares equally to the UK wide figure of 12.3%.

The highest total for a first half year in Doncaster occurred in 2009 when a total of 1,056 were formed.

### new companies by half year



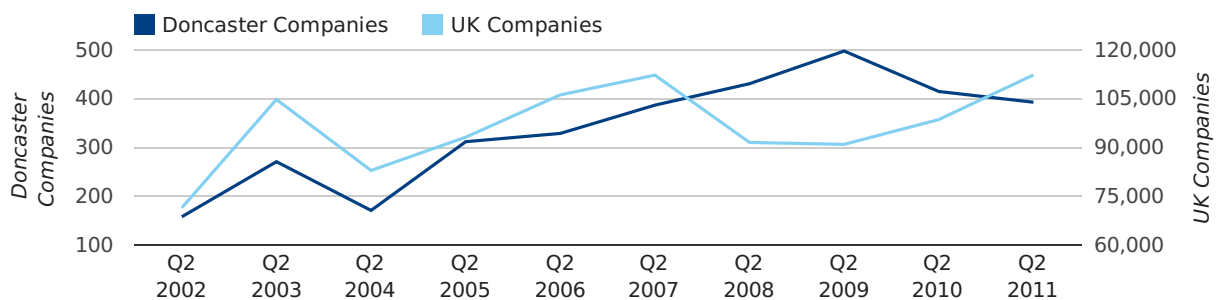
### Quarterly Data (Q2 Apr-Jun 2011)

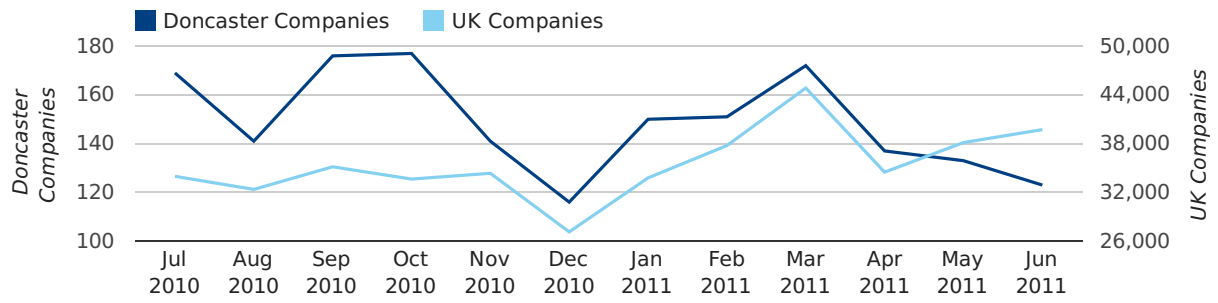

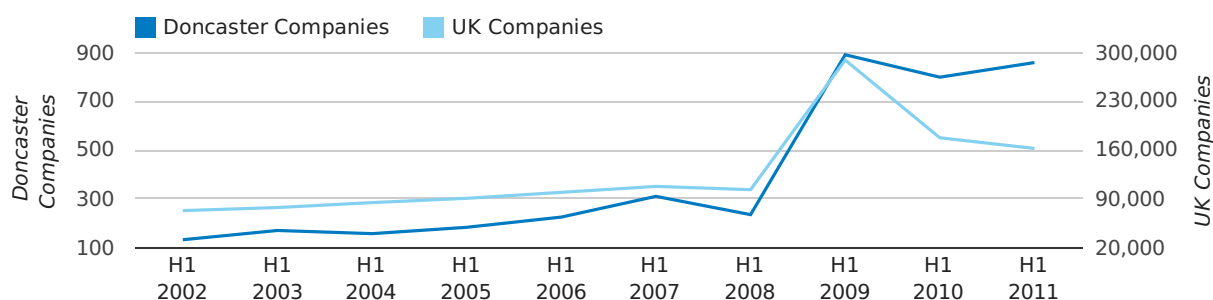
### Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 859 companies were dissolved in Doncaster. This figure is 7.5% higher than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in Doncaster occurred in 2009 when a total of 891 were closed.

### dissolved companies by half year



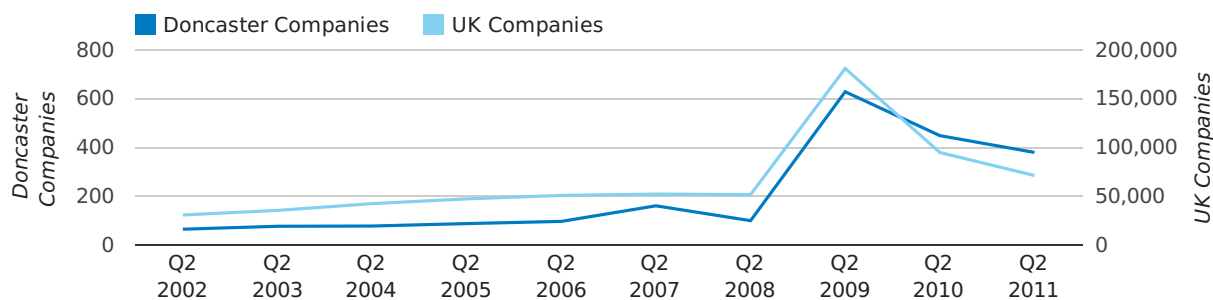
### Quarterly Data (Q2 Apr-Jun 2011)

This figure is a decrease of 15.4% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.

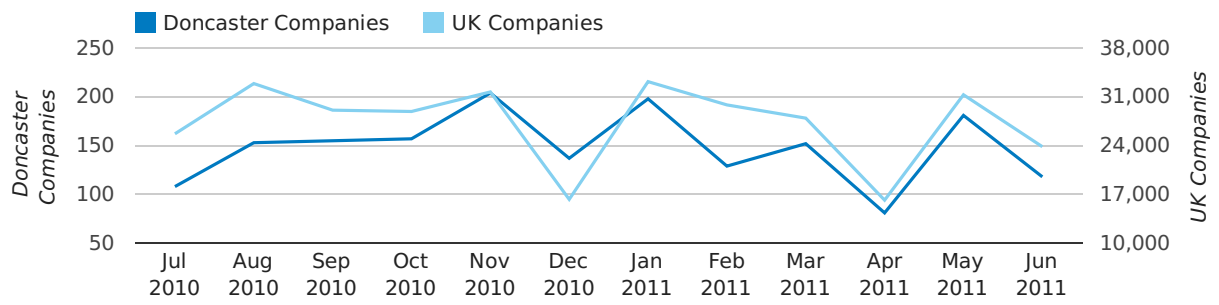

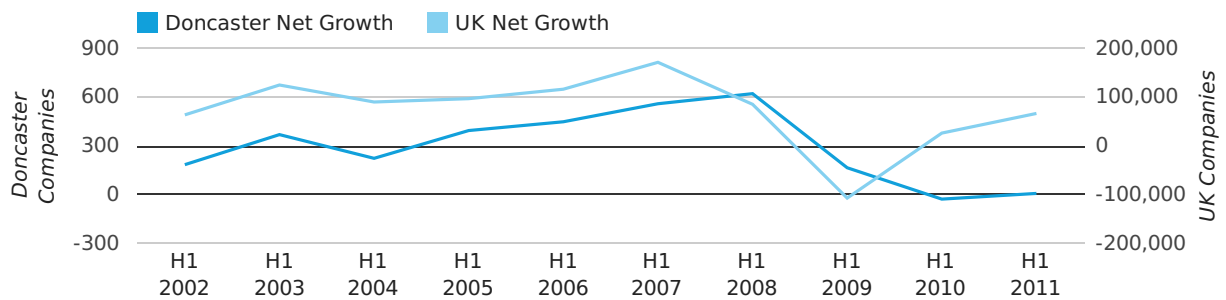

### net growth by half year



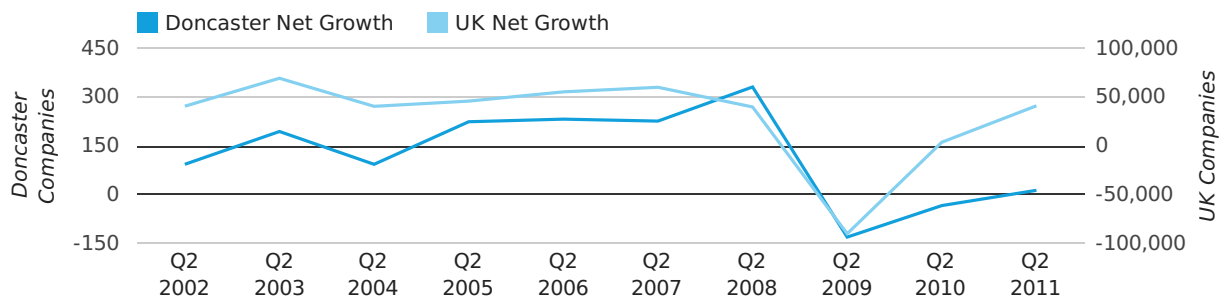
### Quarterly Data (Q2 Apr-Jun 2011)

This represents an increase of 138.2% on the same period last year.

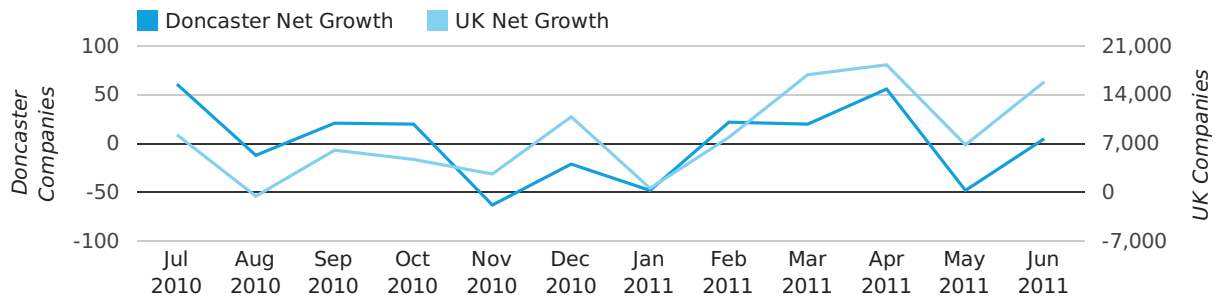

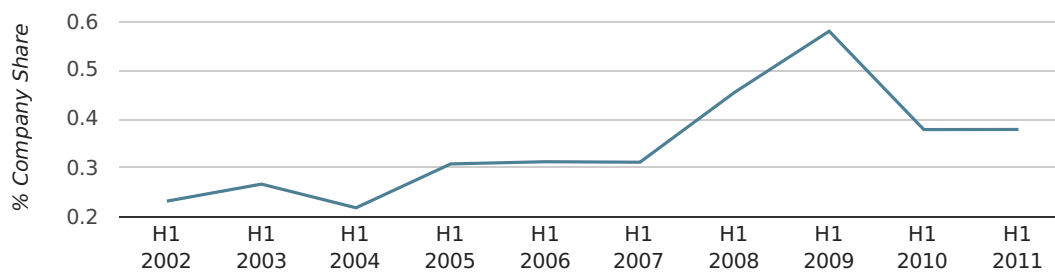

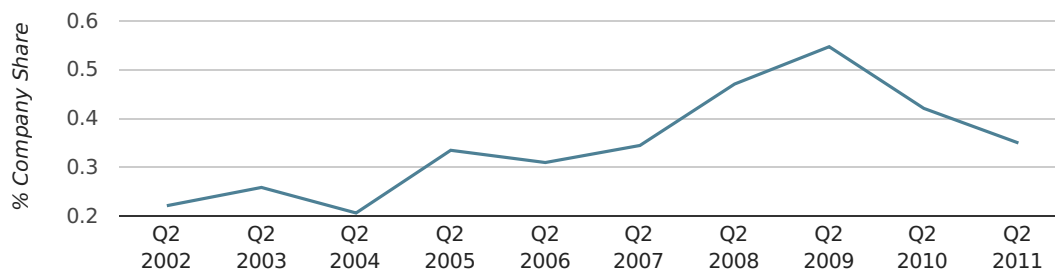

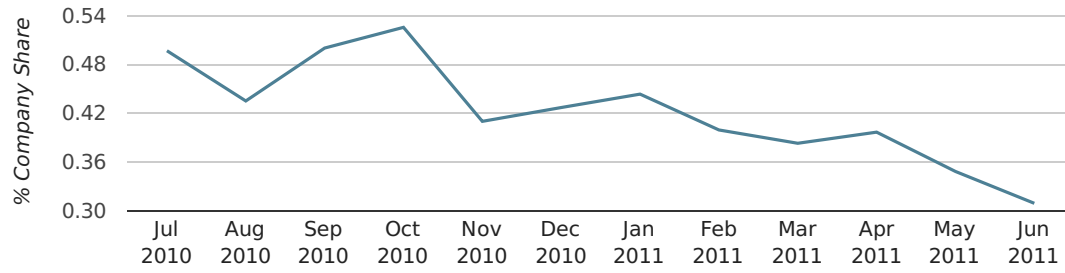

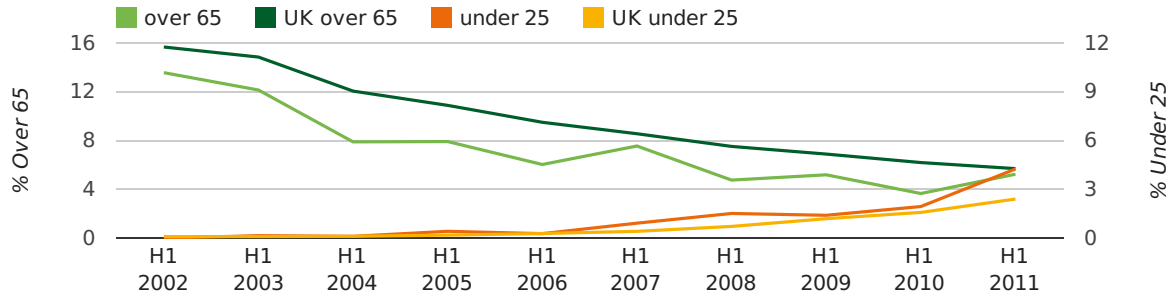
### Half Year Data (Jan-Jun 2011)

#### director age by half year



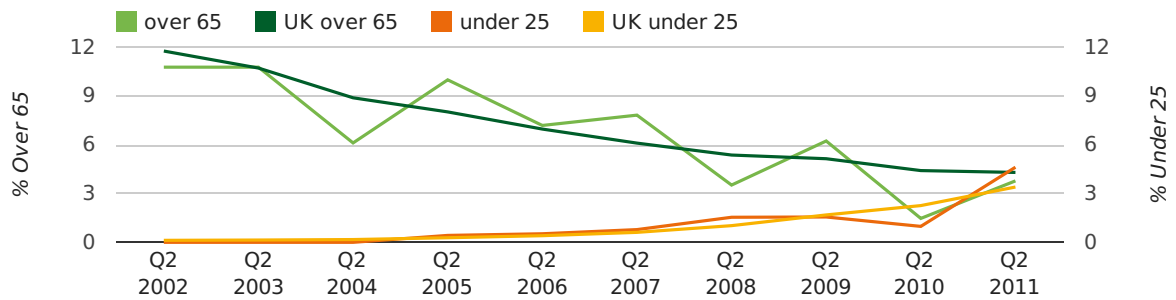
### Quarterly Data (Q2 Apr-Jun 2011)

#### director age by quarter

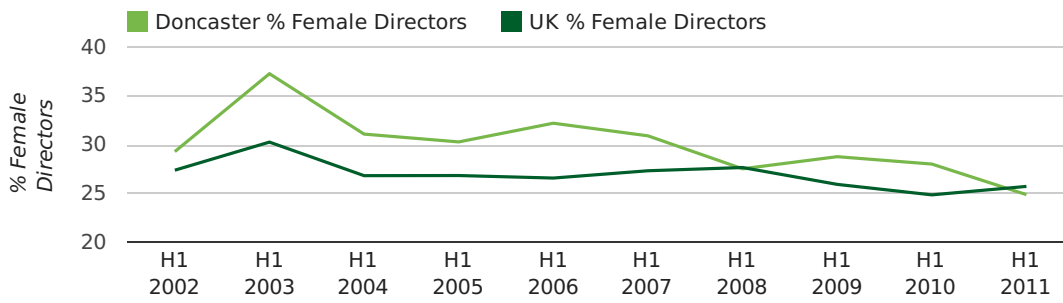


### Half Year Data (Jan-Jun 2011)

#### director gender by half year

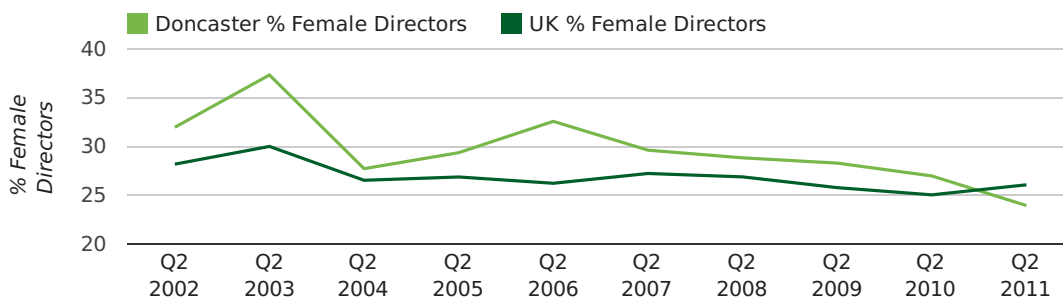


### Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Doncaster was in 1866 when 66.7% of all directors were female.
