

new companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



net growth by half year





Net company growth for Doncaster during the second quarter of 2012 (Apr 2012 - Jun 2012) was -31 companies.





company share by half year







director age by half year





The percentage of directors over the age of 65 was 3.8% compared to the UK figure of 3.3%.


director age by quarter

director gender by half year


