




Half Year Data (Jul-Dec 2011)




new companies by half year

A total of 70 companies were registered in Dorking during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)


dissolved companies by half year


A total of 52 companies were added to the company register for Dorking in 2011. This number represents growth of 20.6% which compares unfavourably to the UK figure of 34.6%.

net growth by year





net growth by quarter






company share by year




company share by half year





director age by year




director age by half year

director gender by year




Half Year Data (Jul-Dec 2011)
