

A total of 449 companies were formed in Dover in 2011. This total is 39.0% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Dover when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Dover when compared to any previous Q4.






Q4 2011 saw a new record in company closures in Dover when compared to any previous Q4.


dissolved companies by quarter

2011 was a record year for net growth in Dover when compared to any year in history.


A total of 233 companies were added to the company register for Dover in 2011. This number represents growth of 72.1% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Dover during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 42 companies.



company share by year




company share by half year





director age by year





director age by half year



director gender by year



director gender by half year


