
The first half of 2012 was a record first half year for company registrations in Droitwich when compared to any half year in history.

In the first half of 2012 a total of 177 companies were formed in Droitwich. This figure is 12.7% higher than last year, which compares well to the UK wide figure of 10.7%.


Q2 2012 saw a new record in company registrations in Droitwich when compared to any previous Q2.


#### new companies by quarter



#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)




The first half of 2012 saw a new record in net growth in Droitwich when compared to any previous first half year.


Q2 2012 saw a new record in net growth in Droitwich when compared to any previous Q2.


#### net growth by quarter









## director age by half year





The percentage of directors over the age of 65 was 4.8% compared to the UK figure of 3.3%.


#### director age by quarter

30.2% of all director appointments in Droitwich in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

The record second quarter for female directors in Droitwich was in 1866 when 66.7% of all directors were female.
