

A total of 490 companies were formed in Dudley in 2011. This total is 14.5% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.




Quarterly Data (Q4 Oct-Dec 2011)

A total of 107 companies were registered in Dudley during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Dudley when compared to any previous Q4.


A total of 148 companies were added to the company register for Dudley in 2011. This number represents growth of 34.6% which compares equally to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)




Net company growth for Dudley during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 2 companies.

net growth by quarter






company share by year







director age by year




director age by half year


director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
