


The second half of 2011 saw a new record in company registrations in Dunfermline when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Dunfermline when compared to any previous Q4.


new companies by quarter



The second half of 2011 saw a new record in company closures in Dunfermline when compared to any previous second half year.


The second half of 2011 was a record second half year for company closures in Dunfermline when compared to any half year in history.

Q4 2011 saw a new record in company closures in Dunfermline when compared to any previous Q4.


Q4 2011 was a record quarter for company closures in Dunfermline when compared to any quarter in history.



2011 was a record year for net growth in Dunfermline when compared to any year in history.


A total of 335 companies were added to the company register for Dunfermline in 2011. This number represents growth of 68.5% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Dunfermline during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 38 companies.


net growth by quarter

net growth by month








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
