


2011 was a record year for company registrations in Dunmow when compared to any year in history.

A total of 209 companies were formed in Dunmow in 2011. This total is 19.4% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Dunmow when compared to any previous second half year.

new companies by half year




A total of 45 companies were registered in Dunmow during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 30 companies were dissolved in Dunmow during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 68 companies were added to the company register for Dunmow in 2011. This number represents growth of 38.9% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Dunmow during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 15 companies.








company share by half year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


