The first half of 2012 saw a new record in company registrations in Dunmow when compared to any previous first half year.

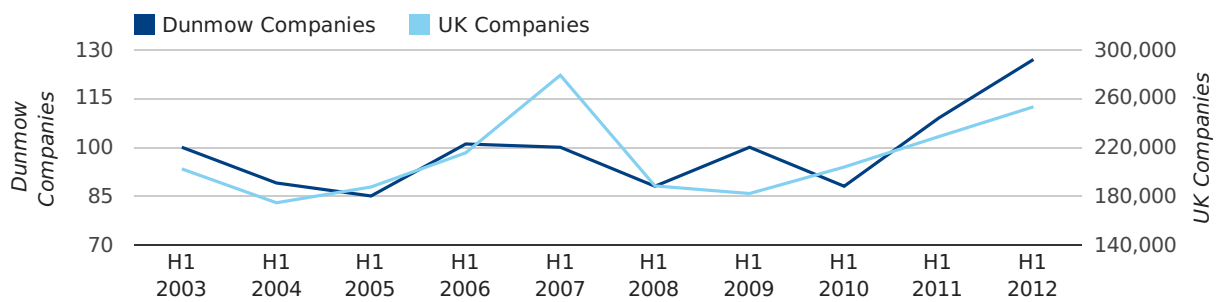
The first half of 2012 was a record first half year for company registrations in Dunmow when compared to any half year in history.

In the first half of 2012 a total of 127 companies were formed in Dunmow. This figure is 16.5% higher than last year, which compares well to the UK wide figure of 10.7%.

Q2 2012 saw a new record in company registrations in Dunmow when compared to any previous Q2.

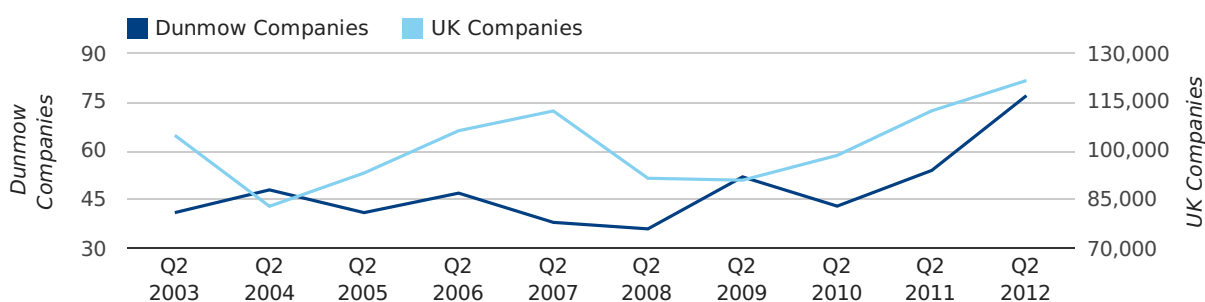
Q2 2012 was a record quarter for company registrations in Dunmow when compared to any quarter in history.

### new companies by quarter



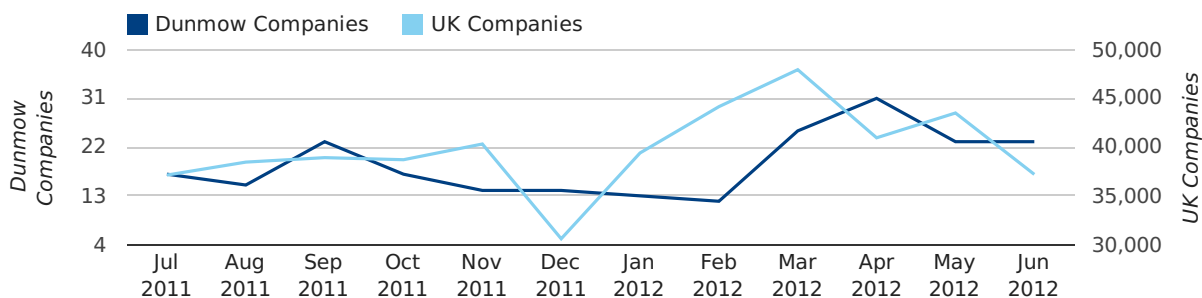

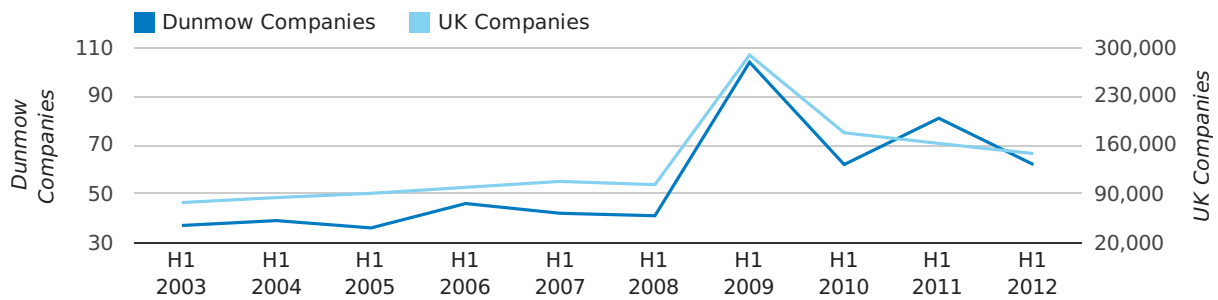
### Half Year Data (Jan-Jun 2012)

### dissolved companies by half year



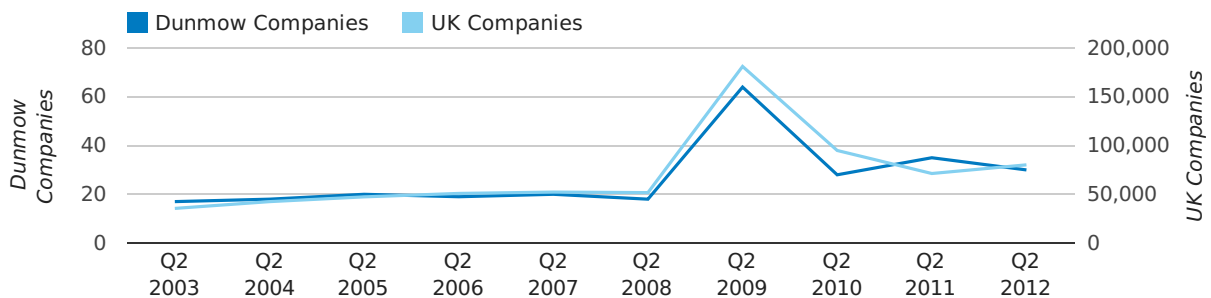
### Quarterly Data (Q2 Apr-Jun 2012)

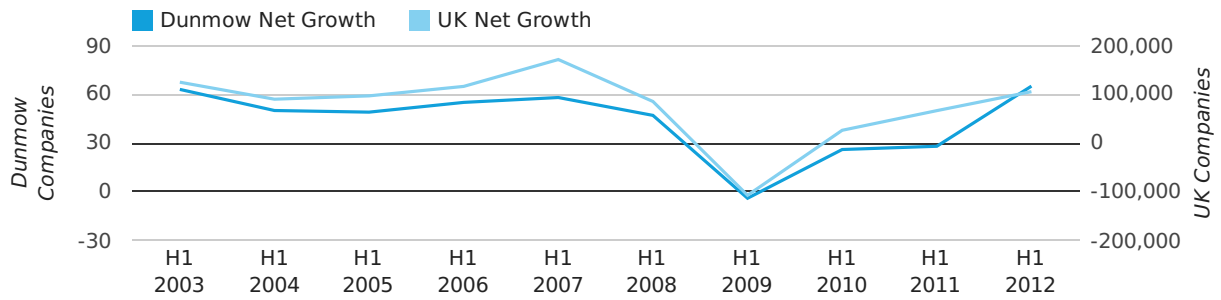
The first half of 2012 saw a new record in net growth in Dunmow when compared to any previous first half year.

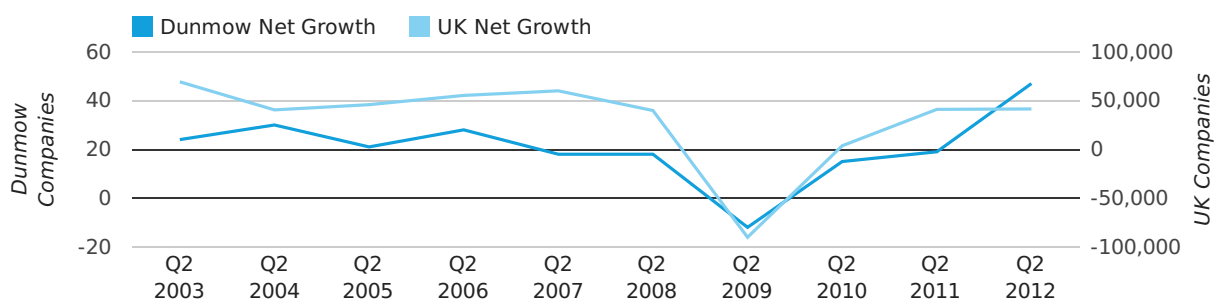

### net growth by quarter

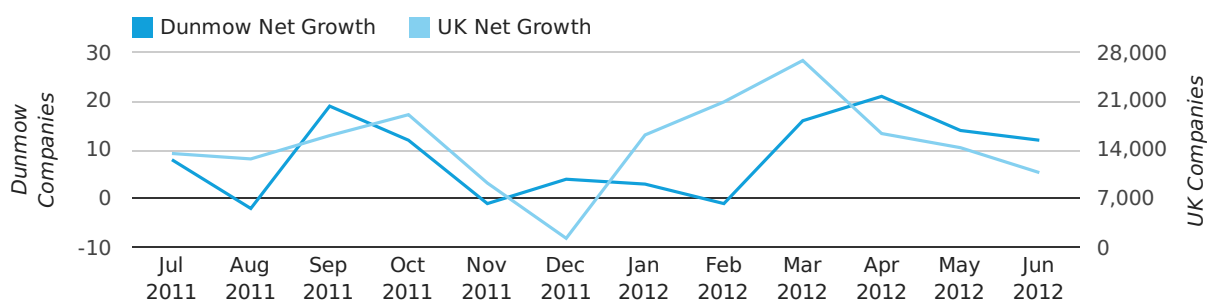

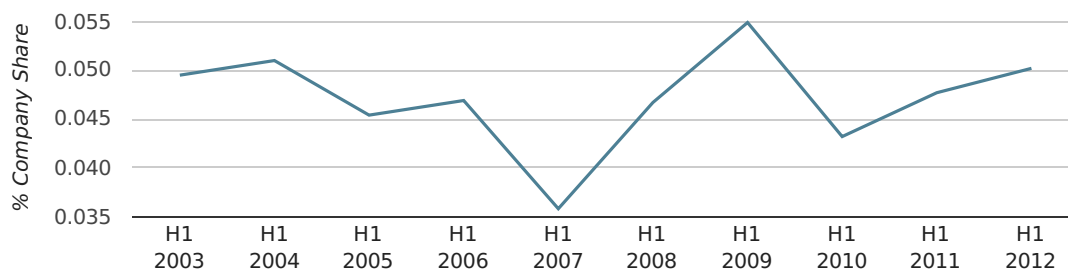

#### company share by half year

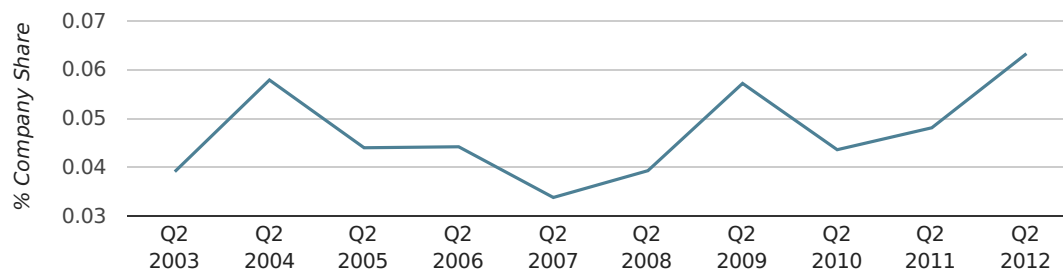

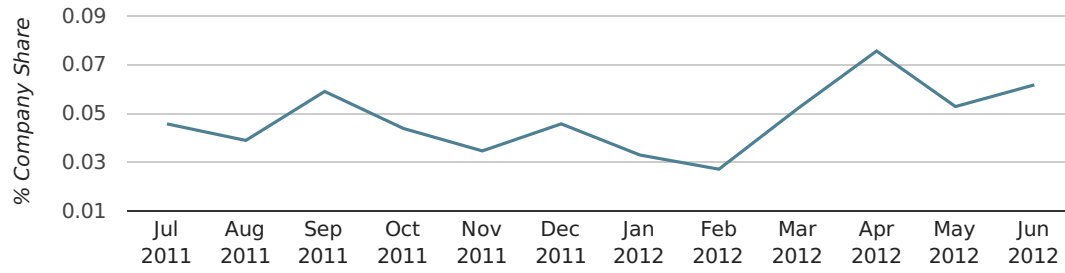

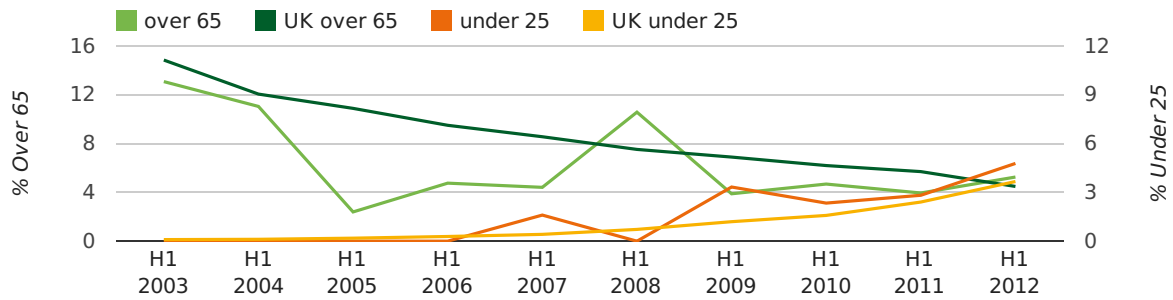
### Half Year Data (Jan-Jun 2012)

#### director age by half year



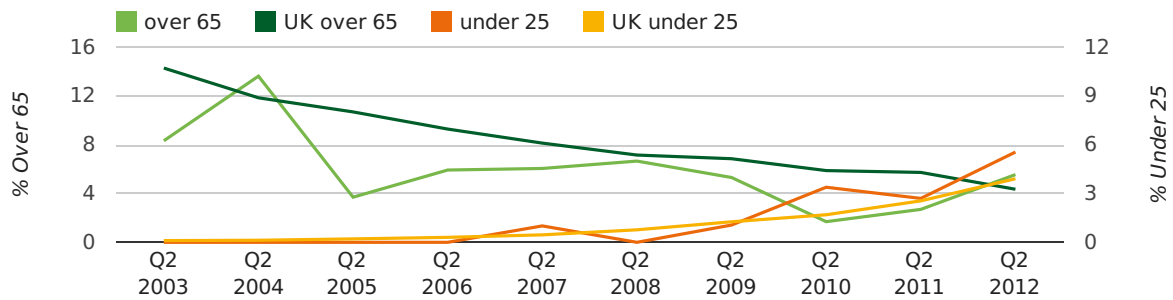
### Quarterly Data (Q2 Apr-Jun 2012)

#### director age by quarter

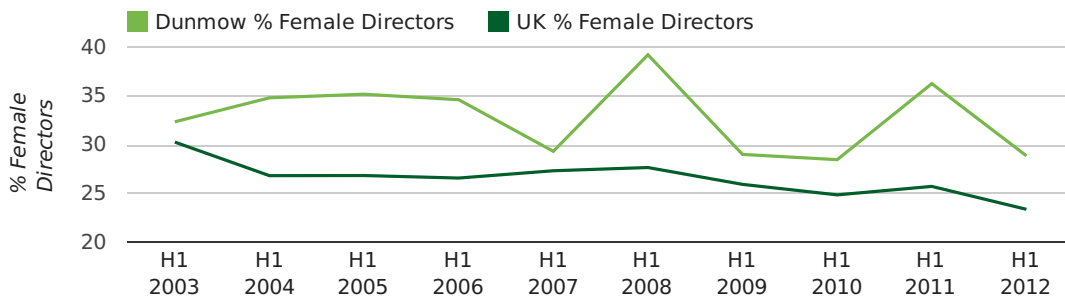


### Half Year Data (Jan-Jun 2012)

The record first half year for female directors in Dunmow was 1861 when 40.0% of all directors were female.

28.9% of all director appointments in Dunmow in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

#### director gender by half year

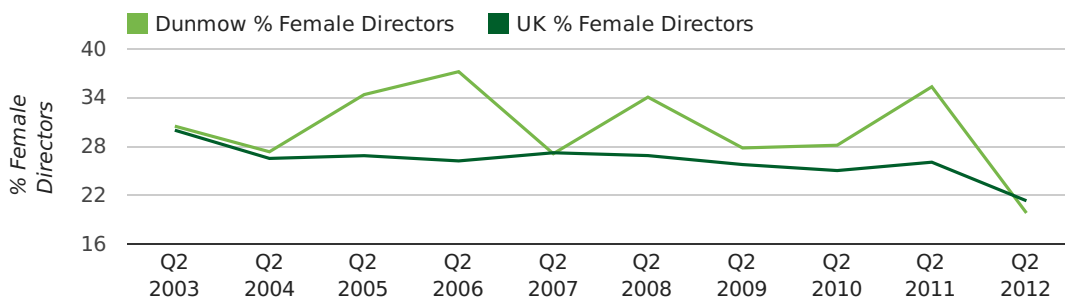


### Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Dunmow was in 1866 when 66.7% of all directors were female.

19.8% of all director appointments in Dunmow in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
