Q1 2011 saw a new record in company registrations in Edinburgh when compared to any previous Q1.


Q1 2011 was a record quarter for company registrations in Edinburgh when compared to any quarter in history.

A total of 1,113 companies were registered in Edinburgh during the first quarter of 2011 (Jan 2011 - Mar 2011).

This figure is an increase of 21.8% versus the same period last year (Q1 2010). This figure compares well to the UK as a whole, which saw an increase of 10.7% against the same period last year.








#### net growth by quarter

#### net growth by month







The percentage of directors over the age of 65 was 3.7% compared to the UK figure of 4.3%.


#### director age by quarter
