
Q3 2011 was a record quarter for company registrations in Edinburgh when compared to any quarter in history.

This figure is an increase of 19.0% versus the same period last year (Q3 2010). This figure compares well to the UK as a whole, which saw an increase of 12.8% against the same period last year.


new companies by quarter













The percentage of directors over the age of 65 was 2.5% compared to the UK figure of 4.1%.


director age by quarter
